A BILL

To waive certain prohibitions with respect to nationals of Cuba coming to the United States to play organized professional baseball.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. REMOVAL OF CERTAIN RESTRICTIONS.
- 4 (a) Restriction on Embargo Authority.—The
- 5 authorities of section 620(a) of the Foreign Assistance Act
- 6 of 1961, those authorities under section 5(b) of the Trad-
- 7 ing With the Enemy Act that were being exercised with
- 8 respect to Cuba on July 1, 1977, as a result of a national

- 1 emergency declared before that date, and are being exer-
- 2 cised on the date of the enactment of this Act, and section
- 3 203 of the International Emergency Economic Powers Act
- 4 may not be exercised to regulate or prohibit—
- 5 (1) those transactions permitted under section
- 6 515.564 of title 31, Code of Federal Regulations, as
- 7 in effect on July 1, 1994, by or on behalf of a
- 8 Cuban national who enters the United States from
- 9 Cuba on a visa issued by the State Department
- under section 101(a)(15)(H)(ii)(b) of the Immigra-
- tion and Nationality Act for the purpose of playing
- organized professional baseball; and
- 13 (2) a Cuban national described in paragraph
- (1) from returning to Cuba the earnings made in
- playing organized professional baseball.
- 16 (b) Restriction on Immigration Authority.—
- 17 The authority contained in section 212(f) of the Immigra-
- 18 tion and Nationality Act may not be used to deny a visa
- 19 described in subsection (a)(1) to a Cuban national for the
- 20 purpose of playing organized professional baseball.
- 21 (c) Inapplicability of Other Restrictions.—
- 22 This section applies notwithstanding section 102(h) of the
- 23 Cuban Liberty and Democratic Solidarity (LIBERTAD)
- 24 Act of 1996.

1 SEC. 2. DURATION OF VISA.

2	A visa described in section $1(a)(1)$ —
3	(1) shall permit the alien to whom the visa is
4	issued to remain in the United States only for the
5	duration of the baseball season; and
6	(2) need not be renewed for subsequent entries
7	into the United States for the duration of a valid
8	contract entered into between the alien and the pro-
9	fessional baseball team with which the alien played
10	in the preceding baseball season.
