- 3 "(1) all regular appropriations for the fiscal
- 4 year (other than for the legislative branch) have
- 5 been enacted into law; or
- 6 "(2) the conference report also contains con-
- 7 tinuing appropriations for the same period in lieu of
- 8 all other regular appropriation bills for the fiscal
- 9 year that have not been enacted into law.
- 10 "(b) It shall not be in order to consider in the House
- 11 any resolution reported from the Committee on Rules pro-
- 12 viding for the consideration of any report of a committee
- 13 of conference that waives paragraph (a).".
- 14 (b) Senate Amendments.—Rule XX of the Rules
- 15 of the House of Representatives is amended by adding at
- 16 the end the following new clause:
- 17 "3. (a) It shall not be in order to consider in the
- 18 House (with respect to any bill or joint resolution) any
- 19 motion to agree to any amendment of the Senate, or any
- 20 motion to agree to any amendment of the Senate with an
- 21 amendment, that contains appropriations for the legisla-
- 22 tive branch for any period of a fiscal year, unless—
- 23 "(1) all regular appropriations for the fiscal
- year (other than for the legislative branch) have
- been enacted into law; or

- 1 "(2) the bill or joint resolution, as proposed to
- 2 be amended, also contains continuing appropriations
- 3 for the same period in lieu of all other regular ap-
- 4 propriation bills for the fiscal year that have not
- 5 been enacted into law.
- 6 "(b) It shall not be in order to consider in the House
- 7 any resolution reported from the Committee on Rules pro-
- 8 viding for the consideration of any report of a committee
- 9 of conference that waives paragraph (a).".
- 10 (c) Continuing Appropriation Measures.—Rule
- 11 XXI of the Rules of the House of Representatives is
- 12 amended by adding at the end the following new clause:
- 13 "9. (a) It shall not be in order to consider in the
- 14 House any bill or joint resolution that contains continuing
- 15 appropriations for the legislative branch for any period of
- 16 a fiscal year, unless—
- 17 "(1) all regular appropriations for the fiscal
- year (other than for the legislative branch) have
- been enacted into law; or
- 20 "(2) the bill or joint resolution also contains
- 21 continuing appropriations for the same period in lieu
- of all other regular appropriation bills for the fiscal
- year that have not been enacted into law.
- 24 "(b) It shall not be in order to consider in the House
- 25 any resolution reported from the Committee on Rules pro-
