Mr. SOLOMON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 1469) making emergency supplemental appropriations for recovery from natural disasters, and for overseas peacekeeping efforts, including those in Bosnia, for the fiscal year ending September 30, 1997, and for other purposes.

- 1 *Resolved*, That at any time after the adoption of this
- 2 resolution of this resolution the Speaker may, pursuant
- 3 to clause 1(b) of rule XXIII, declare the House resolved
- 4 into the Committee of the Whole House on the state of
- 5 the Union for consideration of the bill (H.R. 1469) mak-

1 ing emergency supplemental appropriations for recovery
2 from natural disasters, and for overseas peacekeeping ef-
3 forts, including those in Bosnia, for the fiscal year ending
4 September 30, 1997, and for other purposes. The first
5 reading of the bill shall be dispensed with. All points of
6 order against consideration of the bill are waived. General
7 debate shall be confined to the bill and shall not exceed
8 one hour equally divided and controlled by the chairman
9 and ranking minority member of the Committee on Approp-
10 priations. The amendment printed in part 1 of the report
11 of the Committee on Rules accompanying this resolution
12 and an amendment striking lines 8 through 17 on page
13 24 shall be considered as adopted in the House and in
14 the Committee of the Whole. Points of order against provi-
15 sions in the bill for failure to comply with clause 2 or 6
16 of rule XXI are waived except as follows: page 3, line 1,
17 through line 9; page 10, line 3, through line 15; page 25,
18 line 1, through line 21; page 26, line 8, through line 15;
19 and page 33, line 14, through page 34, line 19. Before
20 consideration of any other amendment it shall be in order
21 to consider the amendments printed in part 2 of the report
22 of the Committee on Rules. Each amendment printed in
23 part 2 of the report may be considered only in the order
24 printed in the report, may be offered only by a Member
25 designated in the report, shall be considered as read, shall

1 be debatable for the time specified in the report equally
2 divided and controlled by the proponent and an opponent,
3 shall not be subject to amendment, and shall not be sub-
4 ject to a demand for division of the question in the House
5 or in the Committee of the Whole. All points of order
6 against the amendments printed in part 2 of the report
7 are waived. During consideration of the bill for further
8 amendment, the Chairman of the Committee of the Whole
9 may accord priority in recognition on the basis of whether
10 the Member offering an amendment has caused it to be
11 printed in the portion of the Congressional Record des-
12 ignated for that purpose in clause 6 of rule XXIII. Amend-
13 ments so printed shall be considered as read. The Chair-
14 man of the Committee of the Whole may: (1) postpone
15 until a time during further consideration in the Committee
16 of the Whole a request for a recorded vote on any amend-
17 ment; and (2) reduce to five minutes the minimum time
18 for electronic voting on any postponed question that fol-
19 lows another electronic vote without intervening business,
20 provided that the minimum time for electronic voting on
21 the first in any series of questions shall be fifteen minutes.
22 During consideration of the bill, points of order against
23 amendments for failure to comply with clause 2(e) of rule
24 XXI are waived. At the conclusion of consideration of the
25 bill for amendment, the Committee shall rise and report

1 the bill to the House with such amendments as may have
2 been adopted. The previous question shall be considered
3 as ordered on the bill and any amendments thereto to final
4 passage without intervening motion except one motion to
5 recommit with or without instructions.
