## RESOLUTION

Honoring the inaugural season of the United States women's professional basketball leagues.

Whereas one in twenty-seven females participated in high school sports in 1970, prior to the passage of title IX of the Higher Education Act;

Whereas one in three women now participate in high school sports;

Whereas female attendance at National Collegiate Athletic Association (NCAA) sports events has increased from 1,100,000 in 1982 to 4,200,000 in 1996;

Whereas the 1995–1996 NCAA student-athlete participation rate is the highest ever, and is directly attributable to gains in women’s sports, and to title IX of the Higher Education Act;

Whereas 97 percent of NCAA active institutions sponsored a women’s basketball program, making women’s basketball the most sponsored NCAA sport during the 1995–1996 season;

Whereas there are more women’s basketball sports programs than men’s basketball programs among NCAA active institutions;

Whereas women account for 38.2 percent of all NCAA student athletes;

Whereas women’s athletics programs at NCAA member schools have increased in participation, scholarship dollars, coaches’ salaries and recruiting expenditures over the past 5 years;

Whereas the average number of women athletes per school in the NCAA’s Division I increased from 112 to 130 over the past 5 years;

Whereas the 1997 Women’s NCAA Division I Basketball Championship was the highest rated and most watched women’s sports event in cable television history;

Whereas the creation of the American Basketball League (ABL) and the Women’s National Basketball Association (WNBA) is a direct result of the success of women’s college basketball;

Whereas the establishment of the ABL and the WNBA is the fourth and fifth attempts respectively to establish nationwide women’s professional basketball associations in American history;

Whereas the ABL completed its opening season March 11  
and the WNBA began its first season on June 21;

Whereas the professional women players deserve to perform  
here in the United States instead of abroad in inter-  
national leagues;

Whereas Team USA's female basketball team won the gold  
medal in the recent Olympics, proving that America's fe-  
male players are the best in international competition;

Whereas 80 million women play basketball around the world,  
and basketball is the most popular youth participation  
sport in the Nation for girls; and

Whereas the leagues will offer role models to young women  
and promote greater female athleticism and equity for  
women's sports, continuing the tradition of gender equity  
in sports first promoted through title IX of the Higher  
Education Act: Now, therefore, be it

1       *Resolved by the House of Representatives, That the*  
2 House of Representatives—

3           (1) congratulates the American Basketball  
4 League (ABL) and the Women's National Basket-  
5 ball Association (WNBA) on their inaugural seasons;  
6 and

7           (2) recognizes the players, sponsors, owners,  
8 and fans of the leagues' teams for their commitment  
9 to supporting women and women's athletics.
