Mr. SOLOMON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 2015) to provide for reconciliation pursuant to subsections (b)(1) and (c) of section 105 of the concurrent resolution on the budget for fiscal year 1998, and for consideration of the bill (H.R. 2014) to provide for reconciliation pursuant to subsections (b)(2) and (d) of section 105 of the concurrent resolution on the budget for fiscal year 1998.

1       *Resolved*, That upon the adoption of this resolution  
2 it shall be in order without intervention of any point of

1 order to consider in the House the bill (H.R. 2015) to  
2 provide for reconciliation pursuant to subsections (b)(1)  
3 and (c) of section 105 of the concurrent resolution on the  
4 budget for fiscal year 1998. The bill shall be considered  
5 as read for amendment. The amendment printed in the  
6 Congressional Record and numbered 1 pursuant to clause  
7 6 of rule XXIII shall be considered as adopted. All points  
8 of order against provisions in the bill, as amended, are  
9 waived. The previous question shall be considered as or-  
10 dered on the bill, as amended, to final passage without  
11 intervening motion except: (1) three hours of debate equal-  
12 ly divided and controlled by the chairman and ranking mi-  
13 nority member of the Committee on the Budget; and (2)  
14 one motion to recommit with or without instructions.

15       SEC. 2. At any time after the adoption of this resolu-  
16 tion the Speaker may, pursuant to clause 1(b) of rule  
17 XXIII, declare the House resolved into the Committee of  
18 the Whole House on the state of the Union for consider-  
19 ation of the bill (H.R. 2014) to provide for reconciliation  
20 pursuant to subsections (b)(2) and (d) of section 105 of  
21 the concurrent resolution on the budget for fiscal year  
22 1998. The first reading of the bill shall be dispensed with.  
23 All points of order against consideration of the bill and  
24 against provisions in the bill, as amended by this resolu-  
25 tion, are waived. General debate shall be confined to the

1 bill and shall not exceed three hours equally divided and  
2 controlled by the chairman and ranking minority member  
3 of the Committee on the Ways and Means. After general  
4 debate the bill shall be considered for amendment under  
5 the five-minute rule. The amendment printed in the Con-  
6 gressional Record and numbered 2 pursuant to clause 6  
7 of rule XXIII shall be considered as adopted in the House  
8 and in the Committee of the Whole. The bill, as amended,  
9 shall be considered as the original bill for the purpose of  
10 further amendment and shall be considered as read. No  
11 other amendment shall be in order except the further  
12 amendment printed in the Congressional Record and num-  
13 bered 1 pursuant to clause 6 of rule XXIII, which may  
14 be offered only by Representative Rangel of New York or  
15 his designee, shall be considered as read, shall be debat-  
16 able for one hour equally divided and controlled by the  
17 proponent and an opponent, shall not be subject to amend-  
18 ment, and shall not be subject to a demand for division  
19 of the question in the House or in the Committee of the  
20 Whole. All points of order against that amendment are  
21 waived. At the conclusion of consideration of the bill, as  
22 amended, for amendment the Committee shall rise and re-  
23 port the bill, as amended, to the House with such further  
24 amendment as may have been adopted. The previous ques-  
25 tion shall be considered as ordered on the bill, as amended,

- 1 and any further amendments thereto to final passage
- 2 without intervening motion except one motion to recommit
- 3 with or without instructions.
