Amending the Rules of the House of Representatives to require the reduction of section 602(b)(1) suballocations to reflect floor amendments to general appropriation bills, and for other purposes.

Mr. ROYCE submitted the following resolution; which was referred to the Committee on Rules

RESOLUTION

Amending the Rules of the House of Representatives to require the reduction of section 602(b)(1) suballocations to reflect floor amendments to general appropriation bills, and for other purposes.

- 1 *Resolved*, That (a) clause 4(a) of rule XI of the Rules
- 2 of the House of Representatives is amended by adding at
- 3 the end the following new subparagraph:
- 4 “(4)(A) Upon the engrossment in the House of any
- 5 general appropriation bill (or resolution making continu-
- 6 ing appropriations (if applicable)), the chairman of the
- 7 Committee on Appropriations shall—

1 “(i) reduce the suballocation of new budget au-
2 thority to the appropriate subcommittee of that com-
3 mittee made under section 602(b)(1) of the Congres-
4 sional Budget Act of 1974 by the net amount of re-
5 ductions in new budget authority resulting from
6 amendments agreed to by the House to that bill, and

7 “(ii) reduce the suballocation of outlays made
8 under section 602(b)(1) of the Congressional Budget
9 Act of 1974 to the appropriate subcommittee of that
10 committee by the net amount of reductions in out-
11 lays resulting from amendments agreed to by the
12 House to that bill,

13 and promptly report those revisions to the House.

14 “(B) The reductions in suballocations made under
15 subdivision (A) may not be reallocated by the Committee
16 on Appropriations to any other subcommittee.

17 “(C) In the House of Representatives, the revised
18 suballocations made under subdivision (A) shall be deemed
19 to be suballocations made under section 602(b)(1) of the
20 Congressional Budget Act of 1974.”.

21 (b) Clause 4(b) of rule XI of the Rules of the House
22 of Representatives is amended by adding at the end the
23 following new sentence: “Upon the reporting of revised

1 suballocations to the House by the Committee on Appro-
2 priations under paragraph (a), the chairman of the Com-
3 mittee on the Budget shall make appropriate revisions in
4 the allocations to the Committee on Appropriations to re-
5 flect the revised suballocations and report those revisions
6 to the House. In the House of Representatives, those re-
7 vised allocations shall be deemed to be allocations made
8 under section 602(a)(1) of the Congressional Budget Act
9 of 1974.”.
