- 5 (a) IN GENERAL.—Rule XXI of the Rules of the

- 10 "(3) Food and Drug Administration.
- 11 "(4) Related agencies with respect to agri-

- "(5) Department of Commerce.
- "(6) Department of Justice.
- 15 "(7) Department of State.
- 16 "(8) Judiciary.
- 17 "(9) Related agencies with respect to the De-
- partments of Commerce, Justice, and State, and the
- 19 Judiciary.
- 20 "(10) Department of Defense military func-
- 21 tions.
- 22 "(11) District of Columbia.
- "(12) Energy and water development.
- 24 "(13) Foreign operations, export financing, and
