Mrs. Maloney of New York submitted the following resolution; which was referred to the Committee on Rules.

RESOLUTION

Providing for the consideration of the bill (H.R. 3526) to reform the financing of Federal elections.

- 1 Resolved, That immediately upon the adoption of this
- 2 resolution the House shall resolve into the Committee of
- 3 the Whole House on the state of the Union for the consid-
- 4 eration of the bill (H.R. 3526) to reform the financing
- 5 of Federal elections. The first reading of the bill shall be
- 6 dispensed with. All points of order against consideration
- 7 of the bill are waived. General Debate shall be confined
- 8 to the bill and shall not exceed two hours, to be divided
- 9 equally between the chairman and ranking minority mem-
- 10 ber of the Committee on House Oversight. After general

- 1 debate the bill shall be considered for amendment under
- 2 the five-minute rule for a period not to exceed 10 hours.
- 3 No amendment shall be in order except amendments print-
- 4 ed in the portion of the Congressional Record designated
- 5 for that purpose in clause 6 of rule XXIII before June
- 6 23, 1998. Each amendment shall be considered as read,
- 7 shall not be subject to amendment, and shall not be sub-
- 8 ject to a demand for the division of the question in the
- 9 House or in the Committee of the Whole. Consideration
- 10 of each amendment shall not exceed one hour. All points
- 11 of order against the amendments are waived except those
- 12 arising under clause 7 of rule XVI. The chairman of the
- 13 Committee of the Whole may postpone until a time during
- 14 further consideration in the Committee of the Whole a re-
- 15 quest for a recorded vote on any amendment, and may
- 16 reduce to five minutes the minimum time for electronic
- 17 voting on any postponed question which follows another
- 18 electronic vote without intervening business, except that
- 19 the minimum time for electronic voting on the first in any
- 20 series of questions shall be fifteen minutes. At the conclu-
- 21 sion of consideration of the bill for amendment the Com-
- 22 mittee shall rise and report the bill to the House with such
- 23 amendments as may have been adopted. The previous
- 24 question shall be considered as ordered on the bill and
- 25 amendments thereto to final passage without intervening

- 1 motion except one motion to recommit, with or without
- 2 instructions.
- 3 Sec. 2. If the Committee of the Whole rises and re-
- 4 ports that it has come to no resolution on the bill, then
- 5 on the next legislative day the House shall, immediately
- 6 after the third daily order of business under clause 1 of
- 7 rule XXIV, resolve into the Committee of the Whole for
- 8 further consideration of the bill.
- 9 Sec. 3. It shall not be in order for the House to con-
- 10 sider any resolution which waives or supersedes any provi-
- 11 sion of this resolution.
