RESOLUTION

Expressing the sense of the House of Representatives that professional sports leagues and the International Olympic Committee should help reinforce the unacceptability and harmfulness of illegal drug use by establishing clear guidelines and penalties, and that athletes using illegal drugs who do not identify the person who provided the illegal drugs and successfully complete a drug treatment program should be suspended from play for a minimum of one year without pay.

2	SECTION 1. SHORT TITLE.
3	This resolution may be cited as the "Drug-Free Pro-
4	fessional and Olympic Athlete Responsibility Resolution".
5	SEC. 2. FINDINGS.
6	The House of Representatives finds as follows:
7	(1) There has been an increase in the number
8	of reports over the last year about athletes who have
9	used illegal drugs, have failed to get effective treat-
10	ment, and have not received appropriate sanctions.
11	(2) Illegal drug use among our Nation's youth
12	has doubled in the 6 years preceding 1997, with sig-
13	nificant increases in the use of marijuana, inhalants,
14	cocaine, methamphetamine, LSD, and heroin.
15	(3) The most dramatic increases in teenage
16	drug use have been among children between the ages
17	of 13 and 14.
18	(4) Professional and Olympic athletes are role
19	models for our Nation's youth, particularly young
20	teenagers.
21	(5) Increases in substance abuse among youth
22	are due in large part to an erosion of understanding
23	by youth of the high risks associated with substance

use, and to the softening of peer norms against use.

1 SEC. 3. SENSE OF THE HOUSE OF REPRESENTATIVES.

- 2 It is the sense of the House of Representatives that—
- 3 (1) all professional sports leagues and the
- 4 International Olympic Committee should help rein-
- 5 force the unacceptability and harmfulness of sub-
- 6 stance abuse by establishing clear guidelines and
- 7 penalties regarding drug abuse, including a written
- 8 policy, treatment assistance programs, and minimum
- 9 penalties that are consistently enforced; and
- 10 (2) athletes who are using illegal drugs who do
- 11 not identify the person who provided the illegal
- drugs and successfully complete a drug treatment
- program should be suspended from play for a mini-
- mum of one year without pay.

15 SEC. 4. DEFINITION.

- In this resolution, the term "illegal drug" means a
- 17 substance listed as a controlled substance under schedules
- 18 I through V of section 202 of the Controlled Substances
- 19 Act (21 U.S.C. 812).
