A BILL

To promote the use of universal product numbers on claims forms used for reimbursement under the medicare program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Medicare Universal
- 5 Product Number Act of 1997".
- 6 SEC. 2. UNIVERSAL PRODUCT NUMBERS ON CLAIMS FORMS
- 7 FOR REIMBURSEMENT UNDER THE MEDI-
- 8 CARE PROGRAM.
- 9 (a) Accommodation of UPNs on Medicare Elec-
- 10 TRONIC CLAIMS FORMS.—Not later than February 1,

- 1 2000, all electronic claims forms developed or used by the
- 2 Secretary of Health and Human Services for reimburse-
- 3 ment under the medicare program under title XVIII of
- 4 the Social Security Act (42 U.S.C. 1395 et seq.) pursuant
- 5 to part C of title XI of that Act (42 U.S.C. 1320d et seq.)
- 6 or any other law shall accommodate the use of universal
- 7 product numbers (as defined in section 1897(a)(2) of that
- 8 Act (as added by subsection (b))) for covered items (as
- 9 defined in section 1834(a)(13) of that Act (42 U.S.C.
- 10 1395m(a)(13)).
- 11 (b) REQUIREMENT FOR PAYMENT OF CLAIMS.—Title
- 12 XVIII of the Social Security Act (42 U.S.C. 1395 et seq.)
- 13 (as amended by section 4015 of the Balanced Budget Act
- 14 of 1997 (Public Law 105–33; 111 Stat. 337)) is amended
- 15 by adding at the end the following:
- "USE OF UNIVERSAL PRODUCT NUMBERS
- "Sec. 1897. (a) Definitions.—In this section:
- 18 "(1) COVERED ITEM.—The term 'covered item'
- has the meaning given that term in section
- 20 1834(a)(13).
- 21 "(2) UNIVERSAL PRODUCT NUMBER.—The
- term 'universal product number' means a number
- that is—
- 24 "(A) affixed by the manufacturer to each
- individual covered item that uniquely identifies
- the item at each packaging level; and

- 1 "(B) based on commercially acceptable
- 2 identification standards established by the Uni-
- 3 form Code Council—International Article Num-
- 4 bering System and the Health Industry Busi-
- 5 ness Communication Council.
- 6 "(b) IN GENERAL.—No payment shall be made under
- 7 this title for any claim for reimbursement for any covered
- 8 item unless the claim contains the universal product num-
- 9 ber of the covered item.".
- 10 (c) Development and Implementation of Pro-
- 11 CEDURES.—From the information obtained by the use of
- 12 universal product numbers (as defined in section
- 13 1897(a)(2) of the Social Security Act (as added by section
- 14 2(b))) on claims for reimbursement under the medicare
- 15 program, the Secretary of Health and Human Services,
- 16 in consultation with interested parties, shall periodically
- 17 review the covered items billed under the Health Care Fi-
- 18 nancing Administration Common Procedure Coding Sys-
- 19 tem and adjust such coding system to ensure that func-
- 20 tionally equivalent covered items are billed and reimbursed
- 21 under the same codes.
- (d) Effective Date.—The amendment made by
- 23 subsection (b) shall apply to claims for reimbursement
- 24 submitted on and after February 1, 2001.

1 SEC. 3. STUDY AND REPORTS TO CONGRESS.

- 2 (a) Study.—The Secretary of Health and Human
- 3 Services shall conduct a study on the results of the imple-
- 4 mentation of the provisions in subsections (a) and (c) of
- 5 section 2 and the amendment to the Social Security Act
- 6 in subsection (b) of that section.
- 7 (b) Reports.—Not later than 6 months after the
- 8 date of enactment of this Act, and annually thereafter,
- 9 the Secretary of Health and Human Services shall submit
- 10 a report to Congress that contains a detailed description
- 11 of the results of the study conducted pursuant to sub-
- 12 section (a), together with the Secretary's recommenda-
- 13 tions regarding the use of universal product numbers (as
- 14 defined in section 1897(a)(2) of the Social Security Act
- 15 (as added by section 2(b) of this Act)) and the use of data
- 16 obtained from the use of such numbers.
