3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Justice for Atomic Vet-
5 erans Act of 1997”.

1 **SEC. 2. EXPANSION OF LIST OF DISEASES PRESUMED TO**
 2 **BE SERVICE CONNECTED FOR RADIATION-EX-**
 3 **POSED VETERANS.**

4 Section 1112(c)(2) of title 38, United States Code,
 5 is amended by adding at the end the following:

6 “(P) Lung cancer.

7 “(Q) Bone cancer.

8 “(R) Skin cancer.

9 “(S) Colon cancer.

10 “(T) Posterior subcapsular cataracts.

11 “(U) Non-malignant thyroid nodular disease.

12 “(V) Ovarian cancer.

13 “(W) Parathyroid adenoma.

14 “(X) Tumors of the brain and central nervous
 15 system.

16 “(Y) Rectal cancer.”.

17 **SECTION 1. SHORT TITLE.**

18 *This Act may be cited as the “Justice for Atomic Veter-*
 19 *ans Act of 1998”.*

20 **SEC. 2. EXPANSION OF LIST OF DISEASES PRESUMED TO BE**
 21 **SERVICE CONNECTED FOR RADIATION-EX-**
