A BILL

To provide for offsetting tax cuts whenever there is an elimination of a discretionary spending program.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Economic Growth and
- 5 Government Efficiency Act of 1997".
- 6 SEC. 2. PROGRAM ELIMINATION EQUALS TAX CUT.
- 7 Section 252 of the Balanced Budget and Emergency
- 8 Deficit Control Act of 1985 (2 U.S.C. 902) is amended
- 9 by adding at the end the following:

| 23 | under paragraph (2) may only be offset by legisla- |

tion decreasing revenues under this section.

- 1 "(4) DISCRETIONARY CAPS.—OMB shall reduce
- 2 the discretionary caps by amounts equal to the
- 3 amounts included as deficit decreases under para-
- 4 graph (2).".

5 SEC. 3. CONGRESSIONAL BUDGET PROCESS.

- 6 Section 314 of the Congressional Budget Act of 1974
- 7 is amended by adding at the end the following:
- 8 "(f) Program Elimination.—Revenue decreases
- 9 offset as provided in section 252(f)(3) of the Balanced
- 10 Budget and Emergency Deficit Control Act of 1985 shall
- 11 not be treated as increasing the deficit for purposes of this
- 12 Act.".
