A BILL

To provide for the conveyance of one (1) acre of land from Santa Fe National Forest to the Village of Jemez Springs, New Mexico, as the site of a fire sub-station.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. FINDINGS.
- 4 (a) The Village of Jemez Springs, New Mexico
- 5 (Jemez Springs), is an incorporated town under the laws
- 6 of the State of New Mexico, and is completely surrounded
- 7 the Jemez National Recreation Area within the Santa Fe
- 8 National Forest;

- 1 (b) Jemez Springs is a small community of approxi-
- 2 mately 460 residents, however given it's location within
- 3 the Jemez National Recreation Area, as many as 30,000
- 4 people will pass through this town on any given day;
- 5 (c) The large size of the tourist crowds within the
- 6 surrounding national recreation area create a strain on
- 7 Jemez Springs' emergency response capabilities. Over
- 8 ninety (90) percent of the ambulance, fire, and emergency
- 9 rescue calls are outside of the town limits.
- 10 (d) The State of New Mexico has appropriated funds
- 11 for Jemez Springs to build a fire sub-station to handle
- 12 the increase in emergency response needs, however, the
- 13 town does not have suitable land upon which to build the
- 14 sub-station.
- 15 SEC. 2. LAND CONVEYANCE, SANTA FE NATIONAL FOREST,
- 16 NEW MEXICO
- 17 (a) Conveyance.—The Secretary of Agriculture
- 18 shall convey, to Jemez Springs all right, title, and interest
- 19 of the United States in and to a parcel of real property,
- 20 together with any improvements thereon, consisting of ap-
- 21 proximately one acre located in the Santa Fe National
- 22 Forest in the State of New Mexico. The emergency serv-
- 23 ices provided by Jemez Springs to the visitors of the Santa
- 24 Fe National Recreation Area shall be deemed adequate

- 1 consideration to the United States for the purposes of this
- 2 conveyance.
- 3 (b) Condition of Conveyance.—The conveyance
- 4 under subsection (a) shall be subject to the condition that
- 5 Jemez Springs agrees to use the real property for the pur-
- 6 pose of constructing and operating a fire sub-station for
- 7 Jemez Springs.
- 8 (c) Reversionary Interest.—If the Secretary de-
- 9 termines that the real property conveyed under subsection
- 10 (a) is not being used in accordance with the condition in
- 11 subsection (b), all right, title, and interest in and to the
- 12 property shall revert to the United States, and the United
- 13 States shall have immediate right of entry thereon.
- 14 (d) Description of Property.—The exact acreage
- 15 and legal description of the real property conveyed under
- 16 subsection (a) shall be determined by a survey satisfactory
- 17 to the Secretary. The cost of the survey shall be borne
- 18 by Jemez Springs.
- 19 (e) Additional Terms and Conditions.—The
- 20 Secretary may require such additional terms and condi-
- 21 tions in connection with conveyance under subsection (a)
- 22 as the Secretary considers appropriate to protect the inter-
- 23 ests of the United States.
