To authorize the Architect of the Capitol to construct a Capitol Visitor Center under the direction of the United States Capitol Preservation Commission, and for other purposes.

Mr. Lott (for himself, Mr. Daschle, and Mr. Warner) introduced the following bill; which was read twice and referred to the Committee on Rules and Administration

# A BILL

- To authorize the Architect of the Capitol to construct a Capitol Visitor Center under the direction of the United States Capitol Preservation Commission, and for other purposes.
  - 1 Be it enacted by the Senate and House of Representa-
  - 2 tives of the United States of America in Congress assembled,
  - 3 SECTION 1. SHORT TITLE.
  - 4 This Act may be cited as the "Capitol Visitor Center
  - 5 Authorization Act of 1997".

#### 1 SEC. 2. ESTABLISHMENT OF CAPITOL VISITOR CENTER.

- 5 (1) to plan, construct, furnish, and equip the
- 6 Capitol Visitor Center under the East Plaza of the

- 8 to the Capitol to provide access thereto; and
- 9 (2) to reconstruct the East Plaza of the United
- 10 States Capitol and its environs to enhance its
- 11 attractiveness, safety, and security;
- 12 in a manner that preserves and maintains Olmstead's
- 13 "General Plan for the Improvement of the United States
- 14 Capitol Grounds", 1874.
- 15 (b) Purposes.—The purposes of the Capitol Visitor
- 16 Center shall include—
- 17 (1) providing reception facilities, educational
- materials and exhibits, information, amenities, a gift
- shop, and other programs and facilities for members
- of the public visiting the United States Capitol; and
- 21 (2) enhancing the security of the Capitol.
- (c) Design.—Plans for construction of the Capitol
- 23 Visitor Center shall be substantially in accordance with
- 24 the Final Design Report dated November 10, 1995, sub-
- 25 mitted by the Architect of the Capitol to the Committee
- 26 on Transportation and Infrastructure of the House of

- 1 Representatives, the Committee on Rules and Administra-
- 2 tion of the Senate, and the United States Capitol Preser-
- 3 vation Commission, subject to modifications approved by
- 4 the Commission.
- 5 (d) EXHIBITS.—The informational and educational
- 6 experience afforded visitors to the Capitol Visitor Center,
- 7 including all exhibits, shall be the responsibility of the
- 8 United States Capitol Visitor Board under the direction
- 9 of the United States Capitol Preservation Commission, as
- 10 approved by the House of Representatives and the Senate.
- 11 The Architect of the Capitol, the Clerk of the House of
- 12 Representatives, the Secretary of the Senate, the Sergeant
- 13 at Arms of the House of Representatives, and the Ser-
- 14 geant at Arms and Doorkeeper of the Senate shall provide
- 15 staff, support, and resources for the installation, assembly,
- 16 and maintenance of all exhibits and other informational
- 17 and educational fixtures and equipment. Exhibits and all
- 18 informational and educational materials shall be subject
- 19 to section 7(b).
- 20 (e) Security Systems.—The design, installation,
- 21 and maintenance of security systems for the Capitol Visi-
- 22 tor Center shall be the responsibility of the Capitol Police
- 23 Board in accordance with section 308 of the Legislative
- 24 Branch Appropriations Act, 1996 (40 U.S.C. 212a-4) and

- 1 section 308 of the Legislative Branch Appropriations Act,
- 2 1997 (40 U.S.C. 212a-4a).
- 3 (f) Management.—After the opening of the Capitol
- 4 Visitor Center to the public, the Architect of the Capitol
- 5 shall administer, maintain, and improve the Capitol Visi-
- 6 tor Center as part of the Capitol Building and Grounds,
- 7 subject to this Act and the oversight of the appropriate
- 8 officers and committees of the House of Representatives
- 9 and the Senate.
- 10 (g) Definition of Project.—In this Act, the term
- 11 "project" means the activities and purposes set forth in
- 12 subsections (a) through (f).
- 13 SEC. 3. UNITED STATES CAPITOL PRESERVATION COMMIS-
- 14 SION; FINANCING PLAN; SECURITY STUDY.
- 15 (a) Development of Project Implementation
- 16 CAPACITY.—Not later than 30 days after the date of en-
- 17 actment of this Act, the United States Capitol Preserva-
- 18 tion Commission shall meet at the call of either co-chair-
- 19 man for the purpose of establishing a special committee
- 20 of the Commission to carry out the functions of the Com-
- 21 mission in implementing and overseeing the project.
- 22 (b) Financing Plan.—As soon as practicable after
- 23 the date of enactment of this Act, the United States Cap-
- 24 itol Preservation Commission shall develop a detailed plan

- 1 for financing the project at the lowest net cost to the Gov-
- 2 ernment. The financing plan shall provide for—
- 3 (1) the acceptance of donations from public and
- 4 private sources to be used to minimize the use of or
- 5 to repay any appropriated or borrowed funds;
- 6 (2) the use of any revenues generated by the
- 7 Capitol Visitor Center to minimize the use of or to
- 8 repay any appropriated or borrowed funds and, to
- 9 the extent available, to pay the operating costs of
- the Capitol Visitor Center;
- 11 (3) the use of any other funds available for the
- preservation and restoration of the Capitol; and
- 13 (4) only to the extent necessary, the use of ap-
- propriated or borrowed funds.
- 15 The plan shall be submitted to Committees on Appropria-
- 16 tions and House Oversight of the House of Representa-
- 17 tives and the Committees on Appropriations and Rules
- 18 and Administration of the Senate.
- 19 (c) REVOLVING FUND.—All funds described in sub-
- 20 section (b) shall be deposited in the United States Capitol
- 21 Visitor Center Revolving Fund, which is hereby estab-
- 22 lished in the Treasury. The Fund shall be managed as
- 23 provided in section 9602 of the Internal Revenue Code of
- 24 1986 and shall be available, without fiscal year limitation,
- 25 to carry out the project, including—

- 1 (1) the reimbursement of appropriations ac-2 counts of the Senate, the House of Representatives, 3 and the Architect of the Capitol for all costs associ-4 ated with the operation of the Capitol Visitor Center
- 6 (2) the payment of costs of the continued con-7 servation and preservation of the Capitol Building; 8 and
- 9 (3) the payment of costs of further acquisitions 10 of fine arts as approved by the Senate Commission 11 on Art or the House Fine Arts Board.
- 12 (d) Security Study.—The Capitol Police Board shall conduct a study to assess security cost savings and other benefits resulting from the construction and oper-14 15 ation of the Capitol Visitor Center and shall report the results of its study to the United States Capitol Preserva-16 tion Commission and to the Committees on Appropriations and House Oversight of the House of Representatives and 18 the Committees on Appropriations and Rules and Admin-19 20 istration of the Senate.

#### 21 SEC. 4. CONSTRUCTION.

22 (a) BUILDING CODES.—The project shall meet design 23 standards applicable under nationally recognized building 24 codes, as determined by the Architect of the Capitol. Dur-25 ing construction, the Architect shall conduct periodic in-

- 1 spections for the purpose of ensuring that such standards
- 2 are being met.
- 3 (b) Applicability of Certain Laws.—The project
- 4 shall not be subject to any Federal or State law (including
- 5 law of the District of Columbia) relating to taxes, building
- 6 codes, studies, reports, permits, or inspections.

#### 7 **SEC. 5. GIFTS.**

- 8 (a) In General.—For the purposes of carrying out
- 9 the project, gifts or donations of services or property may
- 10 be received, accepted, held, and disposed of, subject to the
- 11 provisions of the plan promulgated under section 3.
- 12 (b) Treatment Under Tax Laws.—Any gift ac-
- 13 cepted in accordance with the plan promulgated under sec-
- 14 tion 3 shall be considered a gift to the United States for
- 15 the purposes of income, estate, and gift tax laws of the
- 16 United States.

#### 17 SEC. 6. AUTHORITY TO CONTRACT.

- Notwithstanding any other provision of law, the Ar-
- 19 chitect of the Capitol may establish competitive procedures
- 20 for work on the project by the use of prequalification
- 21 standards and may award contracts on the basis of con-
- 22 tractor qualifications as well as price. Such procedures
- 23 and contract awards shall be final and conclusive upon all
- 24 officers of the Government.

## 1 SEC. 7. CAPITOL VISITOR BOARD.

3	(1) Authority of Capitol Visitor Board.—
4	The Capitol Visitor Board, under the direction of
5	the United States Capitol Preservation Commission
6	and subject to prior approval of the House of Rep-
7	resentatives and the Senate, shall establish the Cap-
8	itol Visitor Center operations, tour, exhibit and edu-
9	cation policies, including—
10	(A) establishing hours of operation, tour
11	content, and tour schedules;
12	(B) producing or selecting films, videos,
13	exhibits, publications, and other items of an
14	educational nature; and
15	(C) approving items for sale by the Capitol
16	Visitor Center gift shop.
17	(2) Consultation.—In carrying out this sec-
18	tion, the Capitol Visitor Board shall consult with the
19	Historians of the Senate and House of Representa-
20	tives, the Senate Commission on Art, the House
21	Fine Arts Board, and any advisory board of the
22	United States Capitol Preservation Commission des-
23	ignated for this purpose by the Commission.
24	(3) Other authorities not affected.—
25	(A) Security.—Nothing in this section
26	affects the authority of the Capitol Police

- Board with respect to security of the Capitol, the Capitol Visitor Center, or their environs.
- 3 (B) SENATE COMMISSION ON ART.—Noth4 ing in this section affects the authority of the
  5 Senate Commission on Art with respect to the
  6 Old Senate Chamber and the Old Supreme
  7 Court Chamber.
- 8 (b) Exhibits and Informational and Edu-9 Cational Material.—
- 10 (1) EXHIBITS.—Exhibits, including any audio,
  11 video, or demonstrative presentations, shall illustrate
  12 the history and the Constitutional role of the United
  13 States Congress and the history, including art and
  14 architectural history, of the Capitol.
  - (2) Informational and educational materials.—To assist visitors, the Capitol Visitor Board shall publish or provide for informational and educational materials for free distribution to the public, in accordance with title 44, United States Code. Materials provided for sale may be purchased through approved procedures for the Capitol Visitor Center gift shop and any revenues produced shall be deposited to the United States Capitol Visitor Center Revolving Fund account as approved by the United States Capitol Preservation Commission.
