 3 **SECTION 1. SENTENCING GUIDELINES FOR COUNTERFEIT-**
 4 **ING OFFENSES.**

5 The United States Sentencing Commission shall
 6 amend the Federal sentencing guidelines to provide—

- 2 *after “or alters”.*
