Mr. CONRAD (for himself and Mr. DORGAN) introduced the following bill;
which was read twice and referred to the Committee on Energy and Nat-
ural Resources

A BILL

To forgive certain debt owed by the city of Dickinson, North
Dakota.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 Congress finds that—

5 (1) the Bureau of Reclamation constructed
6 structures known as the bascule gates on top of the
7 Dickinson Dam on the Heart River, North Dakota,
8 to provide additional water supply in the reservoir
9 known as Patterson Lake for the city of Dickinson,

1 North Dakota, and for additional flood control and
2 other benefits;

3 (2) the gates had to be significantly modified in
4 1982 because of damage resulting from a large ice
5 block causing excessive pressure on the hydraulic
6 system, causing the system to fail;

7 (3) since 1991, the City has received its water
8 supply from the Southwest Water Authority, which
9 provides much higher quality water from the South-
10 west Pipeline Project;

11 (4) the City now receives almost no benefit
12 from the bascule gates because the City does not re-
13 quire the additional water provided by the bascule
14 gates for its municipal water supply;

15 (5) the City has repaid more than \$1.1 million
16 to the United States for the construction of the bas-
17 cule gates, and has been working for several years
18 to reach an agreement with the Bureau of Reclama-
19 tion to alter its repayment contract;

20 (6) the City has a longstanding commitment to
21 improving the water quality and recreation value of
22 the reservoir and has been working with the United
23 States Geological Survey, the North Dakota Depart-
24 ment of Game and Fish, and the North Dakota De-
25 partment of Health to improve water quality; and

1 (7) it is in the public interest to relieve the
2 United States from further risk or obligation in con-
3 nection with the collection of construction costs for
4 the bascule gates by providing for a single payment
5 to the United States in lieu of the scheduled annual
6 payments and for the termination of any further re-
7 payment obligation.

8 **SEC. 2. DEFINITION.**

9 In this Act:

10 (1) **BASCULE GATES.**—The term “bascule
11 gates” means the structure constructed on the Dam
12 to provide additional water storage capacity in the
13 Lake.

14 (2) **CITY.**—The term “City” means the city of
15 Dickinson, North Dakota.

16 (3) **DAM.**—The term “Dam” means Dickinson
17 Dam on the Heart River, North Dakota.

18 (4) **LAKE.**—The term “Lake” means the res-
19 ervoir known as “Patterson Lake” in the State of
20 North Dakota.

21 (5) **SECRETARY.**—The term “Secretary” means
22 the Secretary of the Interior, acting through the
23 Commissioner of the Bureau of Reclamation.

1 **SEC. 3. FORGIVENESS OF DEBT.**

2 (a) IN GENERAL.—The Secretary shall accept a 1-
3 time payment of \$150,000 in lieu of the existing repay-
4 ment obligations of the City under the Bureau of Reclama-
5 tion Contract No. 9–07–60W0384, dated December 19,
6 1988.

7 (b) OWNERSHIP.—Title to the Dam and bascule
8 gates shall remain with the United States.

9 (c) COSTS.—

10 (1) IN GENERAL.—In consultation with the City
11 and the State of North Dakota, the Secretary shall
12 reallocate responsibility for the operation and main-
13 tenance costs of the Dam and bascule gates.

14 (2) CONSIDERATION OF BENEFITS.—The re-
15 allocation of costs shall reflect the fact that the ben-
16 efits of the Dam and bascule gates are mainly for
17 flood control, recreation, and fish and wildlife pur-
18 poses.

19 (d) WATER QUALITY.—

20 (1) IN GENERAL.—The Secretary shall enter
21 into an agreement with the City to make activities
22 to improve water quality of the Lake and to enhance
23 the recreational value of the Lake the responsibility
24 of the City .

1 (2) ASSISTANCE.—The City may seek the as-
2 sistance of Federal agencies to assist in improving
3 the water quality of the Lake.

4 (e) WATER SERVICE CONTRACTS.—The Secretary
5 may enter into appropriate water service contracts if the
6 City seeks to use water from the Lake for municipal water
7 supply or other purposes.
