17	"(1) in the District of Columbia or in interstate
18	or foreign communications by means of telephone—
19	"(A) makes any comment, request, sugges-
20	tion or proposal which is obscene, lewd, lasciv-
21	ious, filthy, or indecent;
22	"(B) makes a telephone call, whether or
23	not conversation ensues, without disclosing his
24	identity and with intent to annoy, abuse,
25	threaten, or harass any person at the called

1	"(C) makes or causes the telephone of an-
2	other repeatedly or continuously to ring, with
3	intent to harass any person at the called num-
4	ber; or
5	"(D) makes repeated telephone calls, dur-
6	ing which conversation ensues, solely to harass
7	any person at the called number; or
8	"(2) knowingly permits any telephone facility
9	under his control to be used for any purpose prohib-
10	ited by this section,
11	shall be fined not more than \$50,000 or imprisoned not
12	more than six months, or both "
