A BILL

To amend the Federal Advisory Committee Act (5 U.S.C. App.) to modify termination and reauthorization requirements for advisory committees, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Advisory Committee
- 5 Termination and Streamlining Act of 1998".

SEC. 2. TERMINATION OF ADVISORY COMMITTEES.

- 2 Section 14 of the Federal Advisory Committee Act
- 3 (5. U.S.C. App.) is amended by adding at the end the fol-
- 4 lowing:
- 5 "(d)(1) Notwithstanding any other provision of law
- 6 (including section 4(a) of this Act and this section) and
- 7 except as provided under paragraph (2), each advisory
- 8 committee established, authorized, or reauthorized by stat-
- 9 ute shall terminate 3 years after the date of enactment
- 10 of the Advisory Committee Termination and Streamlining
- 11 Act of 1998.
- 12 "(2) This subsection shall not apply to any advisory
- 13 committee the purpose of which is to—
- 14 "(A) provide for peer review of Federal grant or
- 15 research applications or similar activities;
- 16 "(B) provide advice and recommendations relat-
- ing to academic certification of Federal institutions;
- 18 or
- "(C) address critical needs relating to health,
- safety, national security, or other concerns as the
- 21 President may certify.
- "(3) Nothing in this subsection shall be construed to
- 23 reauthorize the continuation of any advisory committee
- 24 covered under paragraph (1) beyond the termination date
- 25 specified in the original authorization or any reauthoriza-
- 26 tion for the committee.".

1 SEC. 3. REGULATIONS.

- 2 Section 7(c) of the Federal Advisory Committee Act
- 3 (5 U.S.C. App.) is amended in the first sentence by strik-
- 4 ing: "administrative guidelines" and inserting "regula-
- 5 tions".

6 SEC. 4. ANNUAL REPORT.

- 7 Section 6(c) of the Federal Advisory Committee Act
- 8 (5 U.S.C. App.) is amended by striking the first sentence
- 9 and inserting: "Not later than March 15 of each year, the
- 10 President shall submit an annual report to Congress on
- 11 the activities, status, and changes in the composition of
- 12 advisory committees in existence during the preceding fis-
- 13 cal year.".

14 SEC. 5. ADVISORY COMMITTEE PROCEDURES.

- 15 Section 10(a)(2) of the Federal Advisory Committee
- 16 Act (5 U.S.C. App.) is amended to read as follows:
- 17 "(2) Except when the President determines otherwise
- 18 for reasons of national security, timely notice of each such
- 19 meeting shall be published in the Federal Register. The
- 20 Administrator shall prescribe regulations to provide for
- 21 other types of public notice in addition to, or in lieu of,
- 22 notices in the Federal Register to ensure that all inter-
- 23 ested persons are notified of such meeting prior thereto.".
