## A BILL

To amend chapter 89 of title 5, United States Code, relating to the Federal Employees Health Benefits Program, to enable the Federal Government to enroll an employee and the family of the employee in the program when a State court orders the employee to provide health insurance coverage for a child of the employee but the employee fails to provide the coverage, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Federal Employees  
3 Health Benefits Children’s Equity Act of 1998”.

4 **SEC. 2. ENROLLMENT OF CERTAIN EMPLOYEES AND**  
5 **FAMILY.**

6 Section 8905 of title 5, United States Code, is  
7 amended—

8 (1) by redesignating subsection (f) as sub-  
9 section (g); and

10 (2) by inserting after subsection (e) the follow-  
11 ing:

12 “(f)(1)(A) An unenrolled employee who is required by  
13 a court or administrative order to provide health insurance  
14 coverage for a child who meets the requirements of section  
15 8901(5) may enroll for self and family coverage in a health  
16 benefits plan under this chapter.

17 “(B) The employing agency of an employee described  
18 under subparagraph (A) shall enroll the employee in a self  
19 and family enrollment in the option which provides the  
20 lower level of coverage under the service benefit plan if  
21 the employee—

22 “(i) fails to enroll for self and family coverage  
23 in a health benefits plan that provides full benefits  
24 and services in the location in which the child re-  
25 sides; and

1           “(ii) does not provide documentation dem-  
2           onstrating that the required coverage has been pro-  
3           vided through other health insurance.

4           “(2)(A) An employee who is enrolled as an individual  
5           in a health benefits plan under this chapter and who is  
6           required by a court or administrative order to provide  
7           health insurance coverage for a child who meets the re-  
8           quirements of section 8901(5) may change to a self and  
9           family enrollment in—

10           “(i) the health benefits plan in which the em-  
11           ployee is enrolled; or

12           “(ii) another health benefits plan under this  
13           chapter.

14           “(B) The employing agency of an employee described  
15           under subparagraph (A) shall change the enrollment of  
16           the employee to a self and family enrollment in the plan  
17           in which the employee is enrolled if—

18           “(i) such plan provides full benefits and services  
19           in the location where the child resides; and

20           “(ii) the employee—

21           “(I) fails to change to a self and family en-  
22           rollment; and

23           “(II) does not provide documentation dem-  
24           onstrating that the required coverage has been  
25           provided through other health insurance.

1       “(C) The employing agency of an employee described  
2 under subparagraph (A) shall change the coverage of the  
3 employee to a self and family enrollment in the option  
4 which provides the lower level of coverage under the serv-  
5 ice benefit plan if—

6           “(i) the plan in which the employee is enrolled  
7 does not provide full benefits and services in the lo-  
8 cation in which the child resides; or

9           “(ii) the employee fails to change to a self and  
10 family enrollment in a plan that provides full bene-  
11 fits and services in the location where the child re-  
12 sides.

13       “(3)(A) Subject to subparagraph (B), an employee  
14 who is subject to a court or administrative order described  
15 under this section may not discontinue the self and family  
16 enrollment in a plan that provides full benefits and serv-  
17 ices in the location in which the child resides for the period  
18 that the court or administrative order remains in effect  
19 if the child meets the requirements of section 8901(5) dur-  
20 ing such period.

21       “(B) Enrollment described under subparagraph (A)  
22 may be discontinued if the employee provides documenta-  
23 tion demonstrating that the required coverage has been  
24 provided through other health insurance.”.
