23	dent to services furnished by the qualified acupuncturist
24	that the qualified acupuncturist is legally authorized to

- 3 "(2) The term 'qualified acupuncturist' means an in-
- 4 dividual who has been certified, licensed, or registered as
- 5 an acupuncturist by a State (or under a State regulatory

- 7 (d) Guidance by Secretary of Health and
- 8 Human Services.—The Secretary of Health and Human
- 9 Services shall provide States with guidance regarding what
- 10 services a qualified acupuncturist (as defined in section
- 11 1861(uu)(2) of the Social Security Act (42 U.S.C.
- 12 1395x(uu)(2)) (as added by subsection (c)) should be le-
- 13 gally authorized to perform under State law (or under a
- 14 State regulatory mechanism provided by State law). In
- 15 providing such guidance, the Secretary of Health and
- 16 Human Services shall take into consideration the rec-
- 17 ommendations of the Director of the National Institutes
- 18 of Health relating to the effectiveness of certain acupunc-
- 19 ture services and modalities.
- 20 (e) Effective Date.—The amendments made by
- 21 this section apply to services furnished on or after Janu-
- 22 ary 1, 1999.
