# A BILL

To establish a Commission on Structural Alternatives for the Federal Courts of Appeals.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. ESTABLISHMENT AND FUNCTIONS OF COMMIS-
- 4 SION.
- 5 (a) Establishment.—There is established a Com-
- 6 mission on Structural Alternatives for the Federal Courts
- 7 of Appeals (hereinafter referred to as the "Commission").
- 8 (b) Functions.—The functions of the Commission
- 9 shall be to—

1	(1) study the present division of the United
2	States into the several judicial circuits;
3	(2) study the structure and alignment of the
4	Federal Court of Appeals system, with particular
5	reference to the Ninth Circuit; and
6	(3) report to the President and Congress its
7	recommendations for such changes in circuit bound-
8	aries or structure as may be appropriate for the ex-
9	peditious and effective disposition of the caseload of
10	the Federal Courts of Appeals, consistent with fun-
11	damental concepts of fairness and due process.
12	SEC. 2. MEMBERSHIP.
13	(a) Composition.—The Commission shall be com-
14	posed of 12 members appointed as follows:
15	(1) Two members appointed by the President of
16	the United States.
17	(2) Two members appointed by the Chief Jus-
18	tice of the United States.
19	(3) Two members appointed by the Majority
20	Leader of the Senate.
21	(4) Two members appointed by the Minority
22	Leader of the Senate.
23	(5) Two members appointed by the Speaker of
24	the House of Representatives.

- 1 (6) Two members appointed by the Minority
- 2 Leader of the House of Representatives.
- 3 (b) Appointment.—The members of the Commis-
- 4 sion shall be appointed within 60 days after the date of
- 5 the enactment of this Act.
- 6 (c) Vacancy.—Any vacancy in the Commission shall
- 7 be filled in the same manner as the original appointment.
- 8 (d) Chair.—The Commission shall elect a Chair and
- 9 Vice Chair from among its members.
- 10 (e) Quorum.—Seven members of the Commission
- 11 shall constitute a quorum, but 3 may conduct hearings.
- 12 SEC. 3. COMPENSATION.
- 13 (a) In General.—Members of the Commission who
- 14 are officers, or full-time employees, of the United States
- 15 shall receive no additional compensation for their services,
- 16 but shall be reimbursed for travel, subsistence, and other
- 17 necessary expenses incurred in the performance of duties
- 18 vested in the Commission, but not in excess of the maxi-
- 19 mum amounts authorized under section 456 of title 28,
- 20 United States Code.
- 21 (b) Private Members.—Members of the Commis-
- 22 sion from private life shall receive \$200 per diem for each
- 23 day (including travel time) during which the member is
- 24 engaged in the actual performance of duties vested in the
- 25 Commission, plus reimbursement for travel, subsistence,

- 1 and other necessary expenses incurred in the performance
- 2 of such duties, but not in excess of the maximum amounts
- 3 authorized under section 456 of title 28, United States
- 4 Code.

#### 5 SEC. 4. PERSONNEL.

- 6 (a) EXECUTIVE DIRECTOR.—The Commission may
- 7 appoint an Executive Director who shall receive compensa-
- 8 tion at a rate not exceeding the rate prescribed for level
- 9 V of the Executive Schedule under section 5316 of title
- 10 5, United States Code.
- 11 (b) Staff.—The Executive Director, with approval
- 12 of the Commission, may appoint and fix the compensation
- 13 of such additional personnel as he determines necessary,
- 14 without regard to the provisions of title 5, United States
- 15 Code, governing appointments in the competitive service
- 16 or the provisions of chapter 51 and subchapter III of chap-
- 17 ter 53 of such title relating to classification and General
- 18 Schedule pay rates. Compensation under this subsection
- 19 shall not exceed the annual maximum rate of basic pay
- 20 for a position above GS-15 of the General Schedule under
- 21 section 5108 of title 5, United States Code.
- 22 (c) Experts and Consultants.—The Executive
- 23 Director may procure personal services of experts and con-
- 24 sultants as authorized by section 3109 of title 5, United

- 1 States Code, at rates not to exceed the highest level pay-
- 2 able under the General Schedule pay rates under section
- 3 5332 of title 5, United States Code.
- 4 (d) Services.—The Administrative Office of the
- 5 United States Courts shall provide administrative services,
- 6 including financial and budgeting services, for the Com-
- 7 mission on a reimbursable basis. The Federal Judicial
- 8 Center shall provide necessary research services on a reim-
- 9 bursable basis.

# 10 SEC. 5. INFORMATION.

- 11 The Commission is authorized to request from any
- 12 department, agency, or independent instrumentality of the
- 13 Government any information and assistance the Commis-
- 14 sion determines necessary to carry out its functions under
- 15 this Act. Each such department, agency, and independent
- 16 instrumentality is authorized to provide such information
- 17 and assistance to the extent permitted by law when re-
- 18 quested by the Chair of the Commission.

#### 19 **SEC. 6. REPORT.**

- No later than 2 years following the date on which
- 21 its seventh member is appointed in accordance with sec-
- 22 tion 2(b), the Commission shall submit its report to the
- 23 President and the Congress. The Commission shall termi-
- 24 nate 90 days after the date of the submission of its report.

## 1 SEC. 7. CONGRESSIONAL CONSIDERATION.

- 2 No later than 60 days after the submission of the
- 3 report, the Committee on the Judiciary of the Senate shall
- 4 act on the report.

# 5 SEC. 8. AUTHORIZATION OF APPROPRIATIONS.

- 6 There are authorized to be appropriated to the Com-
- 7 mission such sums, not to exceed \$1,300,000, as may be
- 8 necessary to carry out the purposes of this Act. Such sums
- 9 as are appropriated shall remain available until expended.
