## A BILL

To expand the definition of limited tax benefit for purposes  
of the Line Item Veto Act.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AMENDMENT TO CONGRESSIONAL BUDGET**  
4 **ACT.**

5 Section 1026(9) of the Congressional Budget and Im-  
6 poundment Control Act of 1974 (2 U.S.C. 691e(9))(as  
7 added by the Line Item Veto Act) is amended to read as  
8 follows:

1           “(9) LIMITED TAX BENEFIT.—The term ‘lim-  
2       ited tax benefit’ means any tax provision that has  
3       the practical effect of providing a benefit in the form  
4       of different treatment to a particular taxpayer or a  
5       limited class of taxpayers, whether or not such provi-  
6       sion is limited by its terms to a particular taxpayer  
7       or class of taxpayers.”.
