Mr. Grassley introduced the following bill; which was read twice and referred to the Committee on Agriculture, Nutrition, and Forestry

## A BILL

To provide relief to agricultural producers who granted easements to, or owned or operated land condemned by, the Secretary of the Army for flooding losses caused by water retention at the dam site at Lake Redrock, Iowa, to the extent that the actual losses exceed the estimates of the Secretary.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1	SECTION 1. RELIEF TO AGRICULTURAL PRODUCERS FOR
2	FLOODING LOSS CAUSED BY DAM ON LAKE
3	REDROCK, IOWA.
4	(a) Eligibility.—To be eligible for assistance under
5	this section, an agricultural producer must—
6	(1)(A) be an owner or operator of land who
7	granted an easement to the Federal Government for
8	flooding losses to the land caused by water retention
9	at the dam site at Lake Redrock, Iowa; or
10	(B) have been an owner or operator of land
11	that was condemned by the Federal Government be-
12	cause of flooding of the land caused by water reten-
13	tion at the dam site at Lake Redrock, Iowa; and
14	(2) have incurred losses that exceed the esti-
15	mates of the Secretary of the Army provided to the
16	producer as part of the granting of the easement or
17	as part of the condemnation.
18	(b) Compensation.—
19	(1) In general.—Subject to paragraph (2),
20	the Secretary of the Army shall compensate an eligi-
21	ble producer described in subsection (a) for flooding
22	losses to the land of the producer described in sub-
23	section (a)(2) in an amount determined by the Fed-
24	eral Crop Insurance Corporation.

1	(2) Reduction.—If the Secretary maintains a
2	water retention rate at the dam site at Lake
3	Redrock, Iowa, of—
4	(A) less than 769 feet, the amount of com-
5	pensation provided to a producer under para-
6	graph (1) shall be reduced by 10 percent;
7	(B) not less than 769 feet and not more
8	than 772 feet, the amount of compensation pro-
9	vided to a producer under paragraph (1) shall
10	be reduced by 7 percent; and
11	(C) more than 772 feet, the amount of
12	compensation provided to a producer under
13	paragraph (1) shall be reduced by 3 percent.
14	(c) Crop Years.—This section shall apply to flood-
15	ing losses to the land of a producer described in subsection
16	(a)(2) that are incurred during the 1997 and subsequent
17	crop years.
