## A BILL

To amend title 10, United States Code, to permit retired members of the Armed Forces who have a service-connected disability to receive military retired pay concurrently with veterans' disability compensation.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Military Retirement
- 5 Equity Act of 1997".

1	SEC. 2. CONCURRENT PAYMENT OF RETIRED PAY AND
2	COMPENSATION.
3	(a) Limitation on Duplication of Benefits.—
4	Chapter 71 of title 10, United States Code, is amended
5	by adding at the end the following new section:
6	"§ 1413. Concurrent payment of retired pay and vet-
7	erans' disability compensation
8	"(a) Concurrent Payment.—Subject to subsection
9	(b), a person entitled to retired pay may be paid that pay
10	concurrently with the payment of veterans' disability com-
11	pensation for a service-connected disability if the person's
12	entitlement to retired pay is based solely on—
13	"(1) the person's age;
14	"(2) the length of the person's service in the
15	uniformed services; or
16	"(3) both the person's age and the length of
17	such service.
18	"(b) Offset of Disability Compensation.—In
19	the case of a person who is receiving both retired pay and
20	veterans' disability compensation, the amount of retired
21	pay paid such person shall be reduced (but not below zero)
22	based on the rating of the person's disability for veterans'
23	disability compensation purposes as follows:
24	"(1) If and while the disability is rated 10 per-
25	cent, by the amount equal to 90 percent of the

- 1 amount of the disability compensation paid such per-2 son.
- "(2) If and while the disability is rated 20 percent, by the amount equal to 80 percent of the amount of the disability compensation paid such person.
- 7 "(3) If and while the disability is rated 30 per-8 cent, by the amount equal to 70 percent of the 9 amount of the disability compensation paid such per-10 son.
  - "(4) If and while the disability is rated 40 percent, by the amount equal to 60 percent of the amount of the disability compensation paid such person.
    - "(5) If and while the disability is rated 50 percent, by the amount equal to 50 percent of the amount of the disability compensation paid such person.
- "(6) If and while the disability is rated 60 percent, by the amount equal to 40 percent of the amount of the disability compensation paid such person.
- 23 "(7) If and while the disability is rated 70 per-24 cent, by the amount equal to 30 percent of the

- 15 "(1) Retired pay.—The term 'retired pay' in-
- 16 cludes retainer pay and emergency officers' retire-
- ment pay.
- 18 "(2) Veterans' disability compensation.—
- 19 The term 'veterans' disability compensation' has the
- 20 meaning given the term 'compensation' in section
- 21 101(13) of title 38.".
- 22 (b) Clerical Amendment.—The table of sections
- 23 at the beginning of such chapter is amended by adding
- 24 at the end the following new item:

## 1 SEC. 3. EFFECTIVE DATE AND PROHIBITION ON RETRO-

- 2 **ACTIVE BENEFITS.**
- 3 (a) In General.—The amendments made by this
- 4 Act shall take effect on October 1, 1997.
- 5 (b) Retroactive Benefits.—No benefits shall be
- 6 paid to any person by virtue of this Act for any period
- 7 before the effective date of this Act.
