A BILL

To amend the Public Health Service Act to establish a program of providing information and education to the public on the prevention and treatment of eating disorders.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Eating Disorders In-
- 5 formation and Education Act of 1997".
- 6 SEC. 2. FINDINGS.
- 7 The Congress finds the following:

1	(1) Eating disorders include anorexia nervosa,
2	bulimia nervosa, and binge eating disorder, as well
3	as eating disorders not otherwise defined.
4	(2) Anorexia nervosa and bulimia each can re-
5	sult in death, cardiac impairments, depression, sub-
6	stance abuse, osteoporosis, infertility, amenorrhea,
7	anemia, and other medical conditions.
8	(3) Medical authorities are uncertain to what
9	extent eating disorders are caused by physiological
10	factors, by psychosocial factors, or by both.
11	(4) Such disorders primarily affect women. As
12	many as 7 percent of women may be experiencing
13	eating disorders, and the rate of new cases is in-
14	creasing. As many as 80 percent of women may dur-
15	ing their lifetimes display symptoms of eating dis-
16	orders.
17	(5) There are effective treatments for some eat-
18	ing disorders.
19	SEC. 3. PUBLIC INFORMATION AND EDUCATION ON EATING
20	DISORDERS.
21	Subpart 3 of part B of title V of the Public Health
22	Service Act (42 U.S.C. 290bb–31 et seq.) is amended by
23	adding at the end the following section:
24	"EATING DISORDERS
25	"Sec. 520C. (a) Information and Education.—
26	The Secretary, acting through the Director of the Center

- 1 for Mental Health Services, shall carry out a program to
- 2 provide information and education to the public on the
- 3 prevention and treatment of eating disorders.
- 4 "(b) Toll-Free Telephone Communications.—
- 5 In carrying out subsection (a), the Secretary shall provide
- 6 for the operation of toll-free telephone communications to
- 7 provide information to the public on eating disorders, in-
- 8 cluding referrals for services for the prevention and treat-
- 9 ment of such disorders. Such communications shall be
- 10 available on a 24-hour, 7-day basis.
- 11 "(c) AUTHORIZATION OF APPROPRIATIONS.—For the
- 12 purpose of carrying out this section, there are authorized
- 13 to be appropriated \$2,000,000 for fiscal year 1998, and
- 14 such sums as may be necessary for each of the fiscal years
- 15 1999 and 2000.".
