1 (1) in paragraph (1), by striking "paragraph (2)" and inserting "paragraphs (2) and (3),"; and 2 3 (2) by adding at the end the following: "(3)(A) This subsection does not apply to payments 4 5 made or authorized under— 6 "(i) title II of the Social Security Act, except 7 that a recipient of those payments may send written 8 notification to the Commissioner of Social Security 9 authorizing such payments to be made by electronic 10 funds transfer; or 11 "(ii) chapter 11, 13, or 15 of title 38, except 12 that a recipient of payments under such chapter 13 may send written notification to the Secretary of 14 Veterans Affairs authorizing such payments to be 15 made by electronic funds transfer. 16 "(B) Notification to the Commissioner of Social Se-17 curity or the Secretary of Veterans Affairs under subpara-18 graph (A) shall contain the information described in para-19 graphs (1) and (2) of subsection (g).". 20 (b) Conforming Amendments.—Section 3332(j) of 21 title 31, United States Code (as added by section 31001(x) 22 of Public Law 104–134; 110 Stat. 1321–890) is amend-23 ed— (1) by striking "section—" and inserting "sec-24 25 tion, the following definitions shall apply:";
