A BILL

To amend the Revenue Act of 1987 to provide a permanent extension of the transition rule for certain publicly traded partnerships.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PERMANENT EXTENSION OF TRANSITION RULE**
4 **FOR CERTAIN PUBLICLY TRADED PARTNER-**
5 **SHIPS.**

6 (a) IN GENERAL.—Paragraph (1) of section
7 10211(c) of the Revenue Act of 1987 (Public Law 100–
8 203) is amended to read as follows:

9 “(1) IN GENERAL.—The amendments made by
10 this section shall apply to taxable years beginning

1 after December 31, 1987, except that such amend-
2 ments shall not apply to any existing partnership.”

3 (b) EFFECTIVE DATE.—The amendment made by
4 this section shall take effect as if included in the provisions
5 of section 10211 of the Revenue Act of 1987.
