A BILL

To amend the Small Business Act to promote the partnership of small businesses and federally sponsored research entities to develop commercial applications for research projects, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Small Business Tech-
5 nology Transfer Act of 1997”.

6 **SEC. 2. FINDINGS.**

7 Congress finds that—

1 (1) federally sponsored research at nonprofit in-
 2 stitutions has not been adequately applied to com-
 3 mercial purposes in the past;

4 (2) small businesses have the entrepreneurial
 5 spirit and business experience to apply research for
 6 commercial uses;

7 (3) the partnership between small businesses
 8 and research institutions will create more commer-
 9 cial uses for innovative ideas that will spur the econ-
 10 omy; and

11 (4) although to date the Small Business Tech-
 12 nology Transfer program has produced quality re-
 13 search proposals, an additional evaluation period is
 14 warranted before the program is expanded or made
 15 permanent.

16 **SEC. 3. PURPOSES.**

17 The purpose of this Act is to reauthorize the Small
 18 Business Technology Transfer program for fiscal years
 19 1998 through 2003 to allow for a more complete assess-
 20 ment of the impact and effectiveness of the program.

21 **SEC. 4. SMALL BUSINESS TECHNOLOGY TRANSFER PRO-**
 22 **GRAM.**

23 (a) IN GENERAL.—Section 9(n) of the Small Busi-
 24 ness Act (15 U.S.C. 638(n)) is amended by striking para-
 25 graph (1) and inserting the following:

1 “(1) REQUIRED EXPENDITURE AMOUNTS.—

2 With respect to fiscal years 1998, 1999, 2000, 2001,
3 2002, or 2003, each Federal agency that has an ex-
4 tramural budget for research, or research and devel-
5 opment, in excess of \$1,000,000,000 for that fiscal
6 year, may expend with small business concerns not
7 less than 0.15 percent of that extramural budget
8 specifically in connection with STTR programs that
9 meet the requirements of this section and any policy
10 directives and regulations issued under this sec-
11 tion.”.

12 (b) EFFECTIVE DATE.—The amendment made by
13 this section shall take effect on October 1, 1997.
