To establish a National Panel on Early Reading Research and Effective Reading Instruction.

Mr. COCHRAN introduced the following bill; which was read twice and referred to the Committee on Labor and Human Resources

A BILL

To establish a National Panel on Early Reading Research and Effective Reading Instruction.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Successful Reading
5 Research and Instruction Act”.

6 **SEC. 2. FINDINGS AND PURPOSE.**

7 (a) FINDINGS.—Congress makes the following find-
8 ings:

9 (1) At least 20 percent, and in some States 50
10 to 60 percent, of children in elementary school can-

1 not read at basic levels. The children cannot read
2 fluently and do not understand what they read.

3 (2) Research suggests that the majority of the
4 children, at least 90 to 95 percent, can be brought
5 up to average reading skills if—

6 (A) children at risk for reading failure are
7 identified during the kindergarten and first
8 grade years; and

9 (B) early intervention programs that com-
10 bine instruction in phonological awareness,
11 phonics, and reading comprehension are pro-
12 vided by well-trained teachers.

13 (3) If the early intervention programs described
14 in paragraph (2)(B) are delayed until the children
15 reach 9 years of age (the time that most children
16 are identified), approximately 75 percent of the chil-
17 dren will continue to have reading difficulties
18 through high school.

19 (4) While older children and adults can be
20 taught to read, the time and expense of doing so is
21 enormous.

22 (b) PURPOSE.—The purposes of this Act are—

23 (1) to conduct an assessment of research and
24 knowledge relevant to early reading development,
25 and instruction in early reading, to determine the

1 readiness of the research and knowledge for applica-
 2 tion in the Nation's classrooms;

3 (2) if appropriate, to develop a national strat-
 4 egy for the rapid dissemination of the research and
 5 knowledge to teachers and schools throughout the
 6 United States as a means of facilitating effective
 7 early reading instruction; and

8 (3) to develop a plan for additional research re-
 9 garding early reading development, and instruction
 10 in early reading, if the additional research is war-
 11 ranted.

12 **SEC. 3. NATIONAL PANEL.**

13 (a) IN GENERAL.—The Secretary of Education, or
 14 the Secretary's designee, and the Director of the National
 15 Institute of Child Health and Human Development, or the
 16 Director's designee, jointly shall—

17 (1) establish a National Panel on Early Read-
 18 ing Research and Effective Reading Instruction;

19 (2) establish the membership of the panel in ac-
 20 cordance with subsection (b);

21 (3) select a chairperson of the panel;

22 (4) provide the staff and support necessary for
 23 the panel to carry out the panel's duties; and

1 (5) prepare and submit to Congress a report re-
2 garding the findings and recommendations of the
3 panel.

4 (b) MEMBERSHIP.—The panel shall be composed of
5 15 individuals, who are not officers or employees of the
6 Federal Government. The panel shall include leading sci-
7 entists in reading research, representatives of colleges of
8 education, reading teachers, educational administrators,
9 and parents.

10 (c) DUTIES.—The panel shall—

11 (1) conduct a thorough study of the research
12 and knowledge relevant to early reading develop-
13 ment, and instruction in early reading, including re-
14 search described in section 9 of the Health Research
15 Extension Act of 1985 (42 U.S.C. 281 note);

16 (2) determine which research findings and what
17 knowledge are available for application in the Na-
18 tion's classrooms; and

19 (3) determine how to disseminate the research
20 findings and knowledge to the Nation's schools and
21 classrooms.

22 (d) TERMINATION.—The panel shall terminate 9
23 months after the date of enactment of this Act.
