JOINT RESOLUTION

To direct the Secretary of the Interior to design and construct a permanent addition to the Franklin Delano Roosevelt Memorial in Washington, D.C., and for other purposes.

Whereas President Franklin Delano Roosevelt, after contracting poliomyelitis, required the use of a wheelchair for mobility and lived with this condition while leading the United States through some of its most difficult times; and

Whereas President Roosevelt's courage, leadership, and success should serve as an example and inspiration for all Americans: Now, therefore, be it

- 1 Resolved by the Senate and House of Representatives
- 2 of the United States of America in Congress assembled,
- 3 SECTION 1. ADDITION TO FRANKLIN DELANO ROOSEVELT
- 4 **MEMORIAL.**
- 5 (a) Plan.—The Secretary of the Interior (referred
- 6 to in this Act as the "Secretary") shall plan for the design
- 7 and construction of an addition of a permanent statue,
- 8 bas-relief, or other similar structure to the Franklin Dela-
- 9 no Roosevelt Memorial in Washington, D.C. (referred to
- 10 in this Act as the "Memorial"), to provide recognition of
- 11 the fact that President Roosevelt's leadership in the strug-
- 12 gle by the United States for peace, well-being, and human
- 13 dignity was provided while the President used a wheel-
- 14 chair.
- 15 (b) Commission of Fine Arts.—The Secretary
- 16 shall obtain the approval of the Commission of Fine Arts
- 17 for the design plan created under subsection (a).
- 18 (c) Report.—As soon as practicable, the Secretary
- 19 shall report to Congress and the President on findings and
- 20 recommendations for the addition to the Memorial.
- 21 (d) Construction.—Beginning on the date that is
- 22 120 days after submission of the report to Congress under
- 23 subsection (c), using only private contributions, the Sec-
- 24 retary shall construct the addition according to the plan
- 25 created under subsection (a).

1 SEC. 2. POWERS OF THE SECRETARY.

- 2 To carry out this Act, the Secretary may—
- 3 (1) hold hearings and organize contests; and
- 4 (2) request the assistance and advice of mem-
- 5 bers of the disability community, the Commission of
- 6 Fine Arts, and the National Capital Planning Com-
- 7 mission, and the Commissions shall render the as-
- 8 sistance and advice requested.

9 SEC. 3. COMMEMORATIVE WORKS ACT.

- 10 Compliance by the Secretary with this joint resolution
- 11 shall satisfy all requirements for establishing a commemo-
- 12 rative work under the Commemorative Works Act (40
- 13 U.S.C. 1001 et seq.)

14 SEC. 4. AUTHORIZATION OF APPROPRIATIONS.

- 15 There are authorized to be appropriated to carry out
- 16 this joint resolution such sums as may be necessary.
