Mr. Warner, from the Committee on Rules and Administration, reported under the authority of the order of the Senate of January 30, 1997 the following original resolution; which was placed on the calendar

RESOLUTION

Authorizing expenditures by the Committee on Rules and Administration.

- 1 Resolved, That in carrying out its powers, duties, and
- 2 functions under the Standing Rules of the Senate, in ac-
- 3 cordance with its jurisdiction under rule XXV of such
- 4 rules, including holding hearings, reporting such hearings,
- 5 and making investigations as authorized by paragraphs 1
- 6 and 8 of rule XXVI of the Standing Rules of the Senate,
- 7 the Committee on Rules and Administration is authorized
- 8 from March 1, 1997, through February 28, 1998, and

- 1 March 1, 1998, through February 28, 1999, in its discre-
- 2 tion (1) to make expenditures from the contingent fund
- 3 of the Senate, (2) to employ personnel, and (3) with the
- 4 prior consent of the Government department or agency
- 5 concerned and the Committee on Rules and Administra-
- 6 tion, to use on a reimbursable or non-reimbursable basis
- 7 the services of personnel of any such department or
- 8 agency.
- 9 Sec. 2. (a) The expenses of the committee for the
- 10 period March 1, 1997, through February 28, 1998, under
- 11 this resolution shall not exceed \$1,339,106, of which
- 12 amount (1) not to exceed \$100,000 may be expended for
- 13 the procurement of the services of individual consultants,
- 14 or organizations thereof (as authorized by section 202(i)
- 15 of the Legislative Reorganization Act of 1946, as amend-
- 16 ed), and (2) not to exceed \$20,000 may be expended for
- 17 the training of the professional staff of such committee
- 18 (under procedures specified by section 202(j) of the Legis-
- 19 lative Reorganization Act of 1946).
- 20 (b) For the period March 1, 1998, through February
- 21 28, 1999, expenses of the committee under this resolution
- 22 shall not exceed \$1,375,472, of which amount (1) not to
- 23 exceed \$100,000 may be expended for the procurement of
- 24 the services of individual consultants, or organizations
- 25 thereof (as authorized by section 202(i) of the Legislative

- 1 Reorganization Act of 1946, as amended), and (2) not to
- 2 exceed \$20,000 may be expended for the training of the
- 3 professional staff of such committee (under procedures
- 4 specified by section 202(j) of the Legislative Reorganiza-
- 5 tion Act of 1946).
- 6 Sec. 3. The committee shall report its findings, to-
- 7 gether with such recommendations for legislation as it
- 8 deems advisable, to the Senate at the earliest practicable
- 9 date, but not later than February 28, 1998, and February
- 10 28, 1999, respectively.
- 11 Sec. 4. Expenses of the committee under this resolu-
- 12 tion shall be paid from the contingent fund of the Senate
- 13 upon vouchers approved by the chairman of the commit-
- 14 tee, except that vouchers shall not be required (1) for the
- 15 disbursement of salaries of employees paid at an annual
- 16 rate, (2) for the payment of telecommunications provided
- 17 by the Office of the Sergeant at Arms and Doorkeeper,
- 18 United States Senate, (3) for the payment of stationery
- 19 supplies purchased through the Keeper of the Stationery,
- 20 United States Senate, (4) for payments to the Postmaster,
- 21 United States Senate, (5) for the payment of metered
- 22 charges on copying equipment provided by the Office of
- 23 the Sergeant at Arms and Doorkeeper, United States Sen-
- 24 ate, or (6) for the payment of Senate Recording and Pho-
- 25 tographic Services.

- 1 Sec. 5. There are authorized such sums as may be
- 2 necessary for agency contributions related to the com-
- 3 pensation of employees of the committee from March 1,
- 4 1997, through February 28, 1998, and March 1, 1998,
- 5 through February 28, 1999, to be paid from the Appro-
- 6 priations account for "Expenses of Inquiries and Inves-
- 7 tigations".
