A BILL

To amend title 49, United States Code, relating to civil penalties for unruly passengers of air carriers.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. PENALTIES FOR UNRULY PASSENGERS.
- 4 (a) In General.—Chapter 463 of title 49, United
- 5 States Code, is amended by adding at the end the follow-
- 6 ing:
- 7 "§ 46317. Interference with cabin or flight crew
- 8 "(a) General Rule.—An individual who interferes
- 9 with the duties or responsibilities of the flight crew or
- 10 cabin crew of a civil aircraft or takes any action that poses

- 1 an imminent threat to the safety of the aircraft or other
- 2 individuals on the aircraft is liable to the United States
- 3 Government for a civil penalty of not more than \$25,000.
- 4 In addition or as an alternative, the Secretary of Trans-
- 5 portation may prohibit for not more than 1 year the indi-
- 6 vidual from flying as a passenger on an aircraft used to
- 7 provide air transportation.
- 8 "(b) Notification of Air Carriers.—Not later
- 9 than 10 days after issuing an order prohibiting an individ-
- 10 ual from flying under subsection (a), the Secretary shall
- 11 notify all air carriers of the prohibition and the term of
- 12 such prohibition.
- 13 "(c) Responsibility of Air Carriers.—After a
- 14 notification of an order issued under subsection (a), an
- 15 air carrier who provides air transportation for the individ-
- 16 ual prohibited from flying during the term of such prohibi-
- 17 tion is liable to the United States Government for a civil
- 18 penalty of not more than \$25,000.
- 19 "(d) Compromise and Setoff.—
- 20 "(1) Compromise.—The Secretary may com-
- 21 promise the amount of a civil penalty imposed under
- this section.
- 23 "(2) Setoff.—The Government may deduct
- the amount of a civil penalty imposed or com-

- 1 promised under this section from amounts it owes
- 2 the person liable for the penalty.".
- 3 (b) Conforming Amendment.—The analysis for
- 4 chapter 463 of such title is amended by adding at the end
- 5 the following:

"46317. Interference with cabin or flight crew.".
