A BILL

1	SECTION 1. EQUITABLE RETIREMENT FOR MILITARY RE-
2	SERVE TECHNICIANS.
3	(a) Technicians Covered by CSRS.—Section
4	8336 of title 5, United States Code, is amended by adding
5	at the end the following new subsection:
6	"(p) A military reserve technician (as that term is
7	defined in section 8401(30) of this title), is entitled to an
8	annuity if such technician—
9	"(1) is separated from service as a military re-
10	serve technician after becoming 50 years of age and
11	completing 20 years of such service; or
12	"(2) is separated from service as a military re-
13	serve technician after completing 25 years of such
14	service.".
15	(b) Technicians Covered by FERS.—Section
16	8414(c) of such title is amended—
17	(1) by inserting "(1)" after "(e)"; and
18	(2) by adding at the end the following new
19	paragraph:
20	"(2) A military reserve technician is entitled to an

22	"(1) is separated from service as a military re-
