A BILL

To amend title XVIII of the Social Security Act to eliminate

the time limitation on benefits for immunosuppressive drugs under the Medicare Program.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Immunosuppressive
 5 Drug Coverage Extension Act of 1999”.

6 **SEC. 2. ELIMINATION OF TIME LIMITATION ON MEDICARE**
 7 **BENEFITS FOR IMMUNOSUPPRESSIVE**
 8 **DRUGS.**

9 (a) IN GENERAL.—Section 1861(s)(2)(J) of the So-
 10 cial Security Act (42 U.S.C. 1395x(s)(2)(J)) is amended
 11 by striking “, but only” and all that follows up to the semi-
 12 colon at the end.

13 (b) EFFECTIVE DATE.—The amendment made by
 14 subsection (a) shall apply to drugs furnished on or after
 15 the date of the enactment of this Act.
