5	amount of any monthly periodic benefit payable
6	to the beneficiary for such month which is
7	based upon the beneficiary's earnings while in
8	the service of the Federal Government or any
9	State (or political subdivision thereof, as de-
10	fined in section 218(b)(2)), exceeds
11	"(ii) the reduction base amount, or
12	"(B) an amount equal to two-thirds of the
13	amount of any such monthly periodic benefit.
14	"(2) For purposes of paragraph (1), the term 'reduc-
15	tion base amount' means, in connection with a benefit for
16	a month during any calendar year, the greater of—
17	"(A) \$1,200, or
18	"(B) the amount determined under this para-
19	graph in connection with benefits for months in the
20	preceding calendar year, increased by the percent
21	change described in section 8340(b) of title 5
22	United States Code (determined without regard to
23	any other provision of law) taking effect on Decem-
24	ber 1 of such preceding calendar year.".

1 SEC. 2. EFFECTIVE DATE.

- The amendments made by section 1 shall apply with
- 3 respect to monthly insurance benefits payable under title
- 4 II of the Social Security Act for months ending after the

5 date of the enactment of this Act.
