## A BILL

To direct the Secretary of Defense to provide financial assistance to the Tri-State Maritime Safety Association of Delaware, New Jersey, and Pennsylvania for use for maritime emergency response on the Delaware River.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. FINANCIAL ASSISTANCE FOR MARITIME EMER-**  
2 **GENCY RESPONSE ON THE DELAWARE RIVER**  
3 **AND BAY.**

4 (a) IN GENERAL.—From amounts otherwise avail-  
5 able for the Department of Defense for fiscal year 2000,  
6 the Secretary of Defense shall provide \$250,000 in finan-  
7 cial assistance to the Tri-State Maritime Safety Associa-  
8 tion of Delaware, New Jersey, and Pennsylvania for use  
9 for maritime emergency response on the Delaware River.

10 (b) ALLOCATION OF ASSISTANCE.—Assistance pro-  
11 vided by the Secretary under this section shall be allocated  
12 as follows:

13 (1) \$150,000 for startup costs, including sala-  
14 ries for an executive director and support staff and  
15 outreach and training programs.

16 (2) \$100,000 for a study to evaluate emergency  
17 response in the Delaware River maritime commu-  
18 nity, to—

19 (A) determine current regional command,  
20 control, and communications and information  
21 management capabilities of Federal, State, and  
22 local responders in the Tri-State area;

23 (B) compile a comprehensive list of train-  
24 ing assets and shortfalls in the region covered  
25 by the Tri-State Maritime Safety Association;

1           (C) identify all regional marine response  
2 assets and shortfalls within that region;

3           (D) develop a long-range plan to address  
4 necessary improvements, as identified in the  
5 study;

6           (E) estimate the amount of funding that  
7 would be required to upgrade the command,  
8 control, and communications capabilities in the  
9 region covered by the Tri-State Maritime Safety  
10 Association, based on several alternative reason-  
11 able solutions and timetables; and

12          (F) work toward the overall goal of making  
13 the Delaware River port system a model port  
14 for the Nation with respect to emergency re-  
15 sponse procedures.
