A BILL

To promote youth entrepreneurship education.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. EMPOWERING FUTURE ENTREPRENEURS.
- 4 Title V of the Elementary and Secondary Education
- 5 Act of 1965 is amended—
- 6 (1) by striking the title heading and inserting
- 7 the following:

1	"TITLE V—PROMOTING EQUITY
2	AND EMPOWERMENT"; and
3	(2) by adding at the end the following new part
4	"PART D—EMPOWERING FUTURE
5	ENTREPRENEURS
6	"SEC. 5401. SHORT TITLE AND FINDINGS.
7	"(a) Short Title.—This part may be cited as the
8	"Future Entrepreneurs of America Act".
9	"(b) FINDINGS.—The Congress finds the following
10	"(1) In order to reach their career goals in our
11	dynamic American economy, young people need to
12	take personal responsibility to obtain the skills
13	knowledge, constructive attitudes, and experiences
14	that will enable them to function as creative, self-
15	confident participants in the workforce.
16	"(2) Research has found that 69 percent of
17	high school students are interested in starting their
18	own businesses and 85 percent of such students wish
19	their schools would do more to provide experiences
20	in entrepreneurship and starting a business.
21	"(3) States have begun to express increased in-
22	terest in entrepreneurship education. State edu-
23	cational leaders are recognizing that self-employment
24	is a viable career option for young people and are

exploring ways to better prepare them to own and operate their own businesses.

"(4) As part of a lifelong learning process, entrepreneurship education helps to increase the motivation of young people to learn, helps them develop a sense of individual opportunity, enhances their personal growth, helps them develop an appreciation of the importance of innovation, helps develop their problem solving and leadership skills, helps them learn to manage their finances, and helps them develop the sort of optimistic outlook and self-reliant attitudes that will benefit them for their entire working lives.

- "(5) Entrepreneurship education integrates instruction in economic literacy, including how the economy functions, the workings of the social security system, and the importance of personal savings.
- "(6) The entrepreneurs and inventors of tomorrow are in our schools today. The entrepreneurial spirit needs to be nurtured at all levels of our Nation's educational system beginning with students in grades 7 through 12.

23 "SEC. 5402. STATE GRANT PROGRAM.

24 "(a) AUTHORITY.—In any fiscal year in which the ap-25 propriations under section 5408(a) equal or exceed

1	\$50,000,000, the Secretary shall make grants to States
2	from allocations under subsection (d) to enable them to
3	carry out entrepreneurship education programs for stu-
4	dents in grades 7 through 12.
5	"(b) Agency To Receive Grant.—A grant award
6	to a State under subsection (a) shall be made to the State
7	educational agency.
8	"(c) State Plan.—
9	"(1) Approved state plan required.—No
10	State shall receive a grant under subsection (a) un-
11	less it has submitted to the Secretary a plan, which
12	the Secretary has approved.
13	"(2) State plan contents.—The State plan
14	described in paragraph (1) shall include—
15	"(A) a description of how the State will
16	use a grant;
17	"(B) a description of how the programs
18	supported by a grant will—
19	"(i) involve the business community;
20	and
21	"(ii) be coordinated with other rel-
22	evant Federal, State, regional, and local
23	programs; and
24	"(C) a description of how the State will
25	evaluate program performance.

1	"(d) Allocation of Funds.—
2	"(1) Allocation factors.—Except as other
3	wise provided in paragraph (2), the Secretary shall
4	allocate the amounts made available to carry our
5	this section pursuant to subsection (a) to each State
6	according to the relative populations in all the States
7	of students in grades 7 through 12, as determined
8	by the Secretary based on the most recent satisfac-
9	tory data.
10	"(2) MINIMUM ALLOCATION.—Subject to the
11	availability of appropriations and notwithstanding
12	paragraph (1), a State that has submitted an ap-
13	proved plan under subsection (c) shall be allocated
14	an amount not less than \$400,000 for a fiscal year
15	"(3) Reallocation.—In any fiscal year an al-
16	location under this subsection—
17	"(A) for a State that has not submitted a
18	plan under subsection (c); or
19	"(B) for a State whose plan submitted
20	under subsection (c) has been disapproved by
21	the Secretary;
22	shall be reallocated to the remaining States in ac
23	cordance with paragraph (1).
24	"(e) Use of Grant Funds.—

1	"(1) REQUIRED USES.—A grant made to a
2	State under subsection (a) shall be used—
3	"(A) to provide funds to local educational
4	agencies and public schools to carry out entre-
5	preneurship education programs for students in
6	grades 7 through 12 based on the concept of
7	lifelong learning necessary to encourage the en-
8	trepreneurial spirit; and
9	"(B) to monitor and evaluate programs
10	supported under subparagraph (A).
11	"(2) Permissible use.—A grant made to a
12	State under subsection (a) may be used for profes-
13	sional development that helps to prepare teachers
14	and administrators for entrepreneurial education.
15	"(3) Limitation on administrative costs.—
16	A State receiving a grant under subsection (a) may
17	use not more than 4 percent of the total amount of
18	the grant in each fiscal year for the administrative
19	costs of carrying out this section.
20	"(f) Report to the Secretary.—Each agency re-
21	ceiving a grant as described in subsection (b) shall trans-
22	mit a report to the Secretary with respect to each fiscal
23	year for which a grant was received. The report shall de-
24	scribe the programs supported by the grant and the re-

- 1 sults of the State's monitoring and evaluation of such pro-
- 2 grams.

3 "SEC. 5403. DIRECT LOCAL GRANT PROGRAM.

- 4 "In any fiscal year in which the appropriations under
- 5 section 5408(a) are less than \$50,000,000, the Secretary
- 6 may make grants directly to local educational agencies and
- 7 public schools to provide entrepreneurship education to
- 8 students in grades 7 through 12.

9 "SEC. 5404. CLEARINGHOUSE.

- 10 "(a) AUTHORITY.—The Secretary shall make a grant
- 11 to or execute a contract with an organization or institution
- 12 with substantial experience in the field of entrepreneurship
- 13 education to establish, operate, and maintain a national
- 14 clearinghouse (in this part referred to as the "Clearing-
- 15 house") for instructional materials and information re-
- 16 garding exemplary entrepreneurship education programs
- 17 and best practices.
- 18 "(b) Application.—An organization or institution
- 19 desiring to establish, operate, and maintain the Clearing-
- 20 house shall submit an application to the Secretary at such
- 21 time, in such manner, and accompanied by such informa-
- 22 tion, as the Secretary may reasonably require.
- 23 "(c) Basis and Term.—The Secretary shall make
- 24 the grant or contract authorized by subsection (a) on a
- 25 competitive, merit basis for a term of 5 years.

- 1 "(d) Use of Funds.—The Clearinghouse shall use
- 2 the funds provided under a grant or contract made under
- 3 subsection (a)—
- 4 "(1) to maintain a repository of instructional
- 5 materials and related information regarding entre-
- 6 preneurship education programs for secondary
- 7 schools, including middle schools, for use by States,
- 8 localities, and the general public;
- 9 "(2) to disseminate to States, localities, and the
- 10 general public, through electronic and other means,
- instructional materials and related information re-
- garding entrepreneurship education programs for
- secondary schools, including middle schools; and
- "(3) to the extent that resources allow, to pro-
- 15 vide technical assistance to States, localities, and the
- general public on the design, establishment, and im-
- 17 plementation of entrepreneurship education pro-
- 18 grams for secondary schools, including middle
- schools.
- 20 "(e) Consultation.—The Clearinghouse shall con-
- 21 sult with the Small Business Administration with respect
- 22 to its activities under subsection (d).
- 23 "(f) Submission to Clearinghouse.—Each Fed-
- 24 eral agency or department that develops entrepreneurship
- 25 education programs or instructional materials for such

- 1 programs shall submit to the Clearinghouse information
- 2 on the programs and copies of the materials.
- 3 "(g) Application of Copyright Laws.—In car-
- 4 rying out this section the Clearinghouse shall ensure com-
- 5 pliance with title 17, United States Code.
- 6 "SEC. 5405. EVALUATION.
- 7 "(a) Performance Measures.—The Secretary
- 8 shall develop measures to evaluate the performance of pro-
- 9 grams assisted under sections 5402 and 5403.
- 10 "(b) Evaluation According to Performance
- 11 Measures.—Applying the performance measures devel-
- 12 oped under subsection (a), the Secretary shall evaluate
- 13 programs assisted under sections 5402 and 5403—
- 14 "(1) to judge their performance and effective-
- ness;
- 16 "(2) to identify which of the programs rep-
- 17 resent the best practices of entities developing entre-
- preneurship education programs for students in
- 19 grades 7 through 12; and
- 20 "(3) to identify which of the programs can be
- 21 replicated and used to provide technical assistance to
- 22 States, localities, and the general public.
- 23 "SEC. 5406. REPORT TO THE CONGRESS.
- 24 "For each fiscal year for which there are appropria-
- 25 tions under section 5408(a), the Secretary shall transmit

- 1 a report to the Congress describing the status of the im-
- 2 plementation of this part. The report shall include the re-
- 3 sults of the evaluation required by section 5405 and a de-
- 4 scription of the programs supported under sections 5402
- 5 and 5403.

6 "SEC. 5407. DEFINITIONS.

- 7 "In this part—
- 8 "(1) the term 'entrepreneurship education'
- 9 means educational activities and experiences,
- planned and supervised by qualified teachers, that
- enable students to explore business ownership oppor-
- tunities, acquire the skills and knowledge necessary
- to start a business, and develop a range of entrepre-
- neurial competencies that will help them to explore
- and identify their lifelong career goals as business
- owners or as competent employees; and
- 17 "(2) the term 'qualified teacher' means a teach-
- er who holds a valid teaching certification or is con-
- sidered to be qualified by the State educational
- agency in the State in which the teacher works.

21 "SEC. 5408. AUTHORIZATION OF APPROPRIATIONS.

- 22 "(a) Authorization.—For the purposes of carrying
- 23 out this part, there are authorized to be appropriated
- 24 \$60,000,000 for each of the fiscal years 1999 through
- 25 2004.

- 1 "(b) Limitation on Funds for Clearing-
- 2 House.—The Secretary may use not less than 2 percent
- 3 and not more than 5 percent of amounts appropriated
- 4 under subsection (a) for each fiscal year to carry out sec-
- 5 tion 5404.
- 6 "(c) Limitation on Funds for Secretary's
- 7 EVALUATION.—The Secretary may use not more than
- 8 \$200,000 from the amounts appropriated under sub-
- 9 section (a) for each fiscal year to carry out section 5405.
- 10 "(d) Limitation on Administrative Costs.—Ex-
- 11 cept as necessary to carry out section 5405 using amounts
- 12 described in subsection (c), the Secretary shall not use any
- 13 portion of the amounts appropriated under subsection (a)
- 14 for the costs of administering this part.
- 15 "(e) Funds for Grants.—For each fiscal year the
- 16 Secretary shall use all amounts appropriated under sub-
- 17 section (a), other than the amounts described in sub-
- 18 sections (b) and (c), only for grants under section 5402
- 19 or 5403.".
