4 This Act may be cited as the "COBRA Extension Act5 of 1999".

3	(a) ERISA AMENDMENT.—Section 602(2)(A) of the
4	Employee Retirement Income Security Act of 1974 (29
5	U.S.C. 1162(2)(A)) is amended by inserting after clause
6	(v) the following new clause:
7	"(vi) GENERAL RULE FOR SURVIVING
8	SPOUSES.—In the case of a qualifying
9	event described in section $603(1)$ , the date
10	on which the surviving spouse becomes en-
11	titled to benefits under title XVIII of the
12	Social Security Act.".
13	(b) PHSA AMENDMENT.—Section 2202(2)(A) of the
14	Public Health Service Act (42 U.S.C. 300bb–2(2)(A)) is
15	amended by inserting after clause (iv) the following new
16	clause:
17	"(v) GENERAL RULE FOR SURVIVING
18	spouses.—In the case of a qualifying
19	event described in section $2203(1)$ , the
20	date on which the surviving spouse be-
21	comes entitled to benefits under title XVIII

23	(c) Internal Revenue Code Amendment.—Sec-

tion 4980B(f)(2)(B)(i) of the Internal Revenue Code of
1986 (relating to period of continuation coverage) is

amended by inserting after subclause (V) the following
 new subclause:

3	"(VI) GENERAL RULE FOR SUR-
4	VIVING SPOUSES.—In the case of a
5	qualifying event described in section
6	4980B(f)(3)(A), the date on which the
7	surviving spouse becomes entitled to
8	benefits under title XVIII of the So-
9	cial Security Act.".

(d) EFFECTIVE DATES.—The amendments made by
this section shall apply to qualifying events occurring before or after the date of the enactment of this Act.
