A BILL

To amend title II of the Social Security Act to provide for an improved benefit computation formula for workers affected by the changes in benefit computation rules enacted in the Social Security Amendments of 1977 who attain age 65 during the 10-year period after 1981 and before 1992 (and related beneficiaries) and to provide prospectively for increases in their benefits accordingly.

1 SECTION 1. SHORT TITLE.

- This Act may be cited as the "Notch Baby Act of
- 3 1999".
- 4 SEC. 2. NEW GUARANTEED MINIMUM PRIMARY INSURANCE
- 5 AMOUNT WHERE ELIGIBILITY ARISES DUR-
- 6 ING TRANSITIONAL PERIOD.
- 7 Section 215(a) of the Social Security Act is
- 8 amended—
- 9 (1) in paragraph (4)(B), by inserting "(with or
- without the application of paragraph (8))" after
- "would be made"; and
- 12 (2) by adding at the end the following:
- 13 "(8)(A) In the case of an individual described in
- 14 paragraph (4)(B) (subject to subparagraph (F) of this
- 15 paragraph) who becomes eligible for old-age insurance
- 16 benefits after 1978 and before 1989, the amount of the
- 17 individual's primary insurance amount as computed or re-
- 18 computed under paragraph (1) shall be deemed equal to
- 19 the sum of—
- 20 "(i) such amount, and
- 21 "(ii) the applicable transitional increase amount
- 22 (if any).
- 23 "(B) For purposes of subparagraph (A)(ii), the term
- 24 'applicable transitional increase amount' means, in the
- 25 case of any individual, the product derived by
- 26 multiplying—

1	"(i) the excess under former law, by
2	"(ii) the applicable percentage in relation to the
3	year in which the individual becomes eligible for old-
4	age insurance benefits, as determined by the fol-
5	lowing table:
	"If the individual becomes eligible for such benefits in: The applicable percentage is: 1979 or 1980 60 percent 1981 or 1982 35 percent 1983 or 1984 30 percent 1985 or 1986 25 percent 1987 or 1988 10 percent.
6	"(C) For purposes of subparagraph (B), the term 'ex-
7	cess under former law' means, in the case of any indi-
8	vidual, the excess of—
9	"(i) the applicable former law primary insur-
10	ance amount, over
11	"(ii) the amount which would be such individ-
12	ual's primary insurance amount if computed or re-
13	computed under this section without regard to this
14	paragraph and paragraphs (4), (5), and (6).
15	"(D) For purposes of subparagraph (C)(i), the term
16	'applicable former law primary insurance amount' means,
17	in the case of any individual, the amount which would be
18	such individual's primary insurance amount if it were—
19	"(i) computed or recomputed (pursuant to
20	paragraph (4)(B)(i)) under section 215(a) as in ef-
21	fact in December 1978, or

- 1 "(ii) computed or recomputed (pursuant to
- 2 paragraph (4)(B)(ii)) as provided by subsection (d),
- 3 (as applicable) and modified as provided by subparagraph
- 4 (E).
- 5 "(E) In determining the amount which would be an
- 6 individual's primary insurance amount as provided in sub-
- 7 paragraph (D)—
- 8 "(i) subsection (b)(4) shall not apply;
- 9 "(ii) section 215(b) as in effect in December
- 10 1978 shall apply, except that section 215(b)(2)(C)
- 11 (as then in effect) shall be deemed to provide that
- an individual's 'computation base years' may include
- only calendar years in the period after 1950 (or
- 14 1936 if applicable) and ending with the calendar
- year in which such individual attains age 61, plus
- the 3 calendar years after such period for which the
- total of such individual's wages and self-employment
- income is the largest; and
- "(iii) subdivision (I) in the last sentence of
- paragraph (4) shall be applied as though the words
- 21 'without regard to any increases in that table' in
- such subdivision read 'including any increases in
- 23 that table'.
- 24 "(F) This paragraph shall apply in the case of any
- 25 individual only if such application results in a primary in-

surance amount for such individual that is greater than it would be if computed or recomputed under paragraph 3 (4)(B) without regard to this paragraph.". SEC. 3. EFFECTIVE DATE AND RELATED RULES. 5 (a) Applicability of Amendments.— 6 (1) In General.—Except as provided in para-7 graph (2), the amendments made by this Act shall 8 be effective as though they had been included or re-9 flected in section 201 of the Social Security Amend-10 ments of 1977. 11 (2) Prospective applicability.—No monthly 12 benefit or primary insurance amount under title II 13 of the Social Security Act shall be increased by rea-14 son of such amendments for any month before Janu-15 ary 2000. 16 (b) RECOMPUTATION TO REFLECT BENEFIT IN-17 CREASES.—In any case in which an individual is entitled to monthly insurance benefits under title II of the Social 18 19 Security Act for December 1999, if such benefits are based on a primary insurance amount computed— 20 21 (1) under section 215 of such Act as in effect 22 (by reason of the Social Security Amendments of 23 1977) after December 1978, or 24 (2) under section 215 of such Act as in effect

prior to January 1979 by reason of subsection

- 1 (a)(4)(B) of such section (as amended by the Social
- 2 Security Amendments of 1977),
- 3 the Commissioner of Social Security (notwithstanding sec-
- 4 tion 215(f)(1) of the Social Security Act) shall recompute
- 5 such primary insurance amount so as to take into account
- 6 the amendments made by this Act.
