AN ACT

To amend the Agricultural Trade Act of 1978 to require the President to report to Congress on any selective embargo on agricultural commodities, to provide a termination date for the embargo, to provide greater assurances for contract sanctity, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Selective Agricultural
- 5 Embargoes Act of 1999".
- 6 SEC. 2. REPORTING ON SELECTIVE EMBARGOES.
- 7 The Agricultural Trade Act of 1978 (7 U.S.C. 5711
- 8 et seq.) is amended by adding at the end of title VI:
- 9 "SEC. 604. REPORTING ON SELECTIVE EMBARGOES.
- 10 "(a) Report.—If the President takes any action,
- 11 pursuant to statutory authority, to embargo the export
- 12 under an export sales contract (as defined in subsection
- 13 (e)) of an agricultural commodity to a country that is not
- 14 part of an embargo on all exports to the country, not later
- 15 than 5 days after imposing the embargo, the President
- 16 shall submit a report to Congress that sets forth in detail
- 17 the reasons for the embargo and specifies the proposed
- 18 period during which the embargo will be effective.
- 19 "(b) APPROVAL OF EMBARGO.—If a joint resolution
- 20 approving the embargo becomes law during the 100-day
- 21 period beginning on the date of receipt of the report pro-
- 22 vided for in subsection (a), the embargo shall terminate
- 23 on the earlier of—
- 24 "(1) a date determined by the President; or

1	"(2) the date that is 1 year after the date of					
2	enactment of the joint resolution approving the em-					
3	bargo.					
4	"(c) DISAPPROVAL OF EMBARGO.—If a joint resolu-					
5	tion disapproving the embargo becomes law during the					
6	100-day period referred to in subsection (b), the embarg					
7	shall terminate on the expiration of the 100-day period					
8	"(d) Exception.—Notwithstanding any other provi					
9	sion of this section, an embargo may take effect and con-					
10	tinue in effect during any period in which the United					
11	States is in a state of war declared by Congress or na-					
12	tional emergency, requiring such action, declared by th					
13	President.					
14	"(e) Definitions.—As used in this section—					
15	"(1) the term 'agricultural commodity' includes					
16	plant nutrient materials;					
17	"(2) the term 'under an export sales contract					
18	means under an export sales contract entered into					
19	before the President has transmitted to Congress no-					
20	tice of the proposed embargo; and					
21	"(3) the term 'embargo' includes any prohibi-					
22	tion or curtailment.".					

1	SEC. 3. ADDITION OF PLANT NUTRIENT MATERIALS TO
2	PROTECTION OF CONTRACT SANCTITY.
3	Section 602(c) of the Agricultural Trade Act of 1978
4	(7 U.S.C. 5712(c)) is amended by inserting "(including
5	plant nutrient materials)" after "agricultural commodity"
6	each place it appears.
