 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "LIBERTAD Enforce-
 - 5 ment Act".
 - 6 SEC. 2. REPEAL OF SUSPENSION AUTHORITY.
 - 7 (a) Repeal.—Section 306 of the Cuban Liberty and
 - 8 Democratic Solidarity (LIBERTAD) Act of 1996 (22

- 1 U.S.C. 6085) and the item relating to that section in the
- 2 table of contents of that Act, are repealed.
- 3 (b) Effect on Previous Suspensions.—The re-
- 4 peal made by subsection (a) shall not affect any suspen-
- 5 sion by the President, under subsection (b) of section 306
- 6 of the Cuban Liberty and Democratic Solidarity
- 7 (LIBERTAD) Act of 1996, before the date of the enact-
- 8 ment of this Act.

9 SEC. 3. EFFECTIVE DATE OF TITLE III.

- 10 Title III of the Cuban Liberty and Democratic Soli-
- 11 darity (LIBERTAD) Act of 1996 (22 U.S.C. 6081 and
- 12 following) and the amendments made by that title shall
- 13 take effect upon the expiration of any suspension by the
- 14 President, under subsection (b) of section 306 of the
- 15 Cuban Liberty and Democratic Solidarity (LIBERTAD)
- 16 Act of 1996, that is in effect on the date of the enactment
- 17 of this Act.

18 SEC. 4. CONFORMING AMENDMENTS.

- date of this title" and inserting "on or after the ef-
- 25 fective date of this title"; and

1 (2) in paragraph (3)(B), by striking ", after the 2 end of the 3-month period described in paragraph 3 (1)".
