Mr. Pomeroy (for himself, Mr. Hill of Montana, and Mr. Baldacci) introduced the following bill; which was referred to the Committee on Agriculture

A BILL

To authorize registration of Canadian pesticides for agricultural crops.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Pesticide Registration
- 5 Harmonization Act of 1999".
- 6 SEC. 2. SENSE OF CONGRESS RELATING TO HARMONI-
- 7 ZATION OF REGISTRATION OF CERTAIN PES-
- 8 TICIDES FOR USE ON AGRICULTURAL CROPS.
- 9 (a) Sense of Congress.—It is the sense of Con-
- 10 gress that the President should direct the United States

- 1 representative to the United States-Canada Technical
- 2 Working Group (hereafter referred to as "TWG") to use
- 3 the voice and vote of the United States to urge the TWG
- 4 to make the harmonization of registration of pesticides de-
- 5 scribed in subsection (b) the highest priority.
- 6 (b) Pesticide Defined.—For purposes of this Act,
- 7 a pesticide is a crop protection product which is registered
- 8 in Canada for use on agricultural crops and which is not
- 9 registered in the United States for use on such crops but
- 10 is registered in the United States for other food use crops.
- 11 SEC. 3. ACCEPTANCE OF REGISTRATION FOR CERTAIN PES-
- 12 TICIDES.
- 13 (a) Acceptance of Registration.—Within 180
- 14 days of receiving a written request from the registrant of
- 15 a pesticide in Canada, the Administrator of the Environ-
- 16 mental Protection Agency (hereafter referred to as the
- 17 "Administrator") shall accept registration of the pesticide
- 18 for use in the United States on the same crops as it is
- 19 registered for in Canada unless the Administrator deter-
- 20 mines that substantial evidence exists to preclude United
- 21 States acceptance of the registration.
- 22 (b) Acceptance Requirement.—To be eligible for
- 23 acceptance of a pesticide under subsection (a), the reg-
- 24 istrant shall submit with its request—

- 1 (1) copies of all the data and other registration
- 2 materials submitted to and approved by the Pes-
- 3 ticide Management and Registration Agency of Can-
- 4 ada; and
- 5 (2) an estimate of the expected use of the pes-
- 6 ticide on the crops subject to acceptance and an ex-
- 7 planation of how total use of the pesticide on all
- 8 crops will be made to conform with the applicable re-
- 9 quirements of the Federal Insecticide, Fungicide,
- and Rodenticide Act.
- 11 (c) Priorities.—In deciding whether to accept a
- 12 registration, the Administrator shall take into account the
- 13 priority of harmonizing registrations of pesticides between
- 14 the United States and Canada, as established in the Can-
- 15 ada-United States Trade Agreement and the North Amer-
- 16 ican Free Trade Agreement. A request submitted under
- 17 this section for pesticide registration shall not be counted
- 18 against any other priority submitted by a registrant.
- 19 (d) Denial.—In the event registration of a pesticide
- 20 is denied, the Administrator shall publicly identify the rea-
- 21 sons and causes for the denial.
- 22 SEC. 4. REPORT TO CONGRESS.
- Not later than 1 year after the date of enactment
- 24 of the Act, and every year thereafter, the United States
- 25 representative to the TWG shall report to appropriate

- 1 committees of Congress on the status of TWG efforts to
- 2 harmonize registrations of pesticides for use on agricul-

3 tural crops in the United States and Canada.
