## A BILL

To apply the same quality and safety standards to domestically manufactured handguns that are currently applied to imported handguns.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "American Handgun
- 5 Standards Act of 1999".
- 6 SEC. 2. FINDINGS.
- 7 The Congress finds that—

1	(1) the Gun Control Act of 1968 prohibited the
2	importation of handguns that failed to meet min-
3	imum quality and safety standards;
4	(2) the Gun Control Act of 1968 did not impose
5	any quality and safety standards on domestically
6	produced handguns;
7	(3) domestically produced handguns are specifi-
8	cally exempted from oversight by the Consumer
9	Product Safety Commission and are not required to
10	meet any quality and safety standards;
11	(4) each year—
12	(A) gunshots kill more than 35,000 Ameri-
13	cans and wound approximately 250,000;
14	(B) approximately 75,000 Americans are
15	hospitalized for the treatment of gunshot
16	wounds;
17	(C) Americans spend more than \$20 billion
18	for the medical treatment of gunshot wounds;
19	and
20	(D) gun violence costs the United States
21	economy a total of \$135 billion;
22	(5) the disparate treatment of imported hand-
23	guns and domestically produced handguns has led to
24	the creation of a high-volume market for junk guns,
25	defined as those handguns that fail to meet the

- 1 quality and safety standards required of imported
- 2 handguns;
- 3 (6) traffic in junk guns constitutes a serious
- 4 threat to public welfare and to law enforcement offi-
- 5 cers;
- 6 (7) junk guns are used disproportionately in the
- 7 commission of crimes; and
- 8 (8) the domestic manufacture, transfer, and
- 9 possession of junk guns should be restricted.
- 10 SEC. 3. DEFINITION OF JUNK GUN.
- 11 Section 921(a) of title 18, United States Code, is
- 12 amended by adding at the end the following new para-
- 13 graph:
- 14 "(35) The term 'junk gun' means any handgun that
- 15 does not meet the standard imposed on imported hand-
- 16 guns as described in section 925(d)(3), and any regula-
- 17 tions issued under such section.".
- 18 SEC. 4. RESTRICTION ON MANUFACTURE, TRANSFER, AND
- 19 POSSESSION OF CERTAIN HANDGUNS.
- Section 922 of title 18, United States Code, is
- 21 amended by adding at the end the following new sub-
- 22 section:
- (z)(1) It shall be unlawful for a person to manufac-
- 24 ture, transfer, or possess a junk gun that has been shipped
- 25 or transported in interstate or foreign commerce.

1	"(2) Paragraph (1) shall not apply to—
2	"(A) the possession or transfer of a junk gun
3	otherwise lawfully possessed under Federal law on
4	the date of the enactment of the American Handgun
5	Standards Act of 1999;
6	"(B) a firearm or replica of a firearm that has
7	been rendered permanently inoperative;
8	"(C)(i) the manufacture for, transfer to, or pos-
9	session by, the United States or a State or a depart-
10	ment or agency of the United States, or a State or
11	a department, agency, or political subdivision of a
12	State, of a junk gun; or
13	"(ii) the transfer to, or possession by, a law en-
14	forcement officer employed by an entity referred to
15	in clause (i) of a junk gun for law enforcement pur-
16	poses (whether on or off-duty);
17	"(D) the transfer to, or possession by, a rail po-
18	lice officer employed by a rail carrier and certified
19	or commissioned as a police officer under the laws
20	of a State of a junk gun for purposes of law enforce-
21	ment (whether on or off-duty); or
22	"(E) the manufacture, transfer, or possession
23	of a junk gun by a licensed manufacturer or licensed

- 1 importer for the purposes of testing or experimen-
- 2 tation authorized by the Secretary.".
