| 21 | (a) IN GENERAL.—The Woodrow Wilson Memorial |
| 22 | Bridge Authority Act of 1995 (109 Stat. 627) is amended |

by adding at the end the following:

1 "SEC. 413. AUTHORITY TO PROCEED.

2 "Notwithstanding any other provision of law, after 3 the date of enactment of this section, the Secretary shall 4 approve, and the Secretary, the Authority, and any Cap-5 ital Region jurisdiction are authorized to proceed with, the engineering, design, right-of-way acquisition, and con-6 struction of the Project. All records of decision relating 7 8 to the project issued before such date of enactment shall remain in effect.". 9

(b) CONFORMING AMENDMENT.—The table of contents contained in section 1(b) of the National Highway
System Designation Act of 1995 (109 Stat. 568) is
amended by adding at the end the following:

"Sec. 412. Federal contribution. "Sec. 413. Authority to proceed.".
