A BILL

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. DESIGNATION.**

2 The Federal building located at 500 Pearl Street in
3 New York City, New York, shall be known and designated
4 as the “Ted Weiss United States Courthouse”.

5 **SEC. 2. REFERENCES.**

6 Any reference in a law, map, regulation, document,
7 paper, or other record of the United States to the United
8 States courthouse referred to in section 1 shall be deemed
9 to be a reference to the “Ted Weiss United States Court-
10 house”.

11 **SECTION 1. DESIGNATION.**

12 *The Federal building located at 290 Broadway in New*
13 *York, New York, shall be known and designated as the “Ted*
14 *Weiss Federal Building”.*

15 **SEC. 2. REFERENCES.**

16 *Any reference in a law, map, regulation, document,*
17 *paper, or other record of the United States to the Federal*
18 *building referred to in section 1 shall be deemed to be a*
19 *reference to the “Ted Weiss Federal Building”.*

Amend the title so as to read: “A bill to designate
the Federal building located at 290 Broadway in New
York, New York, as the ‘Ted Weiss Federal Building’.”.
