To amend title 10, United States Code, to improve the authorities relating to the provision of honor guard details at funerals of veterans.

1 Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, SECTION 1. ENHANCEMENT OF AUTHORITIES RELATING 4 TO THE PROVISION OF HONOR GUARD DE-5 TAILS AT FUNERALS OF VETERANS. 6 (a) Duty Status.—Section 1491 of title 10, United 7 States Code, is amended— 8 (1) by redesignating subsections (e) and (f) as subsections (f) and (g), respectively; and 9

- 1 (2) by inserting after subsection (d) the fol-
- 2 lowing new subsection (e):
- 3 "(e) Reserve Duty.—Performance of duty as a
- 4 member of an honor guard detail for the funeral of a vet-
- 5 eran, and training for such duty, by a member of a reserve
- 6 component may be considered to be a period of drill or
- 7 training in addition to training otherwise required.".
- 8 (b) Retirement Points.—Section 12733 of title
- 9 10, United States Code, is amended by adding at the end
- 10 the following new paragraph:
- 11 "(5) One day for each day, not otherwise count-
- ed under this section, on which the person per-
- formed duty as a member of an honor guard detail
- 14 for the funeral of a veteran, or training for such
- duty, that was considered by the Secretary con-
- 16 cerned to be a period of drill or training in addition
- to training otherwise required.".
- 18 (c) Exemption From End Strengths.—A mem-
- 19 ber of a reserve component who is on active duty under
- 20 a call or order to active duty for a period of more than
- 21 180 days and who is retained on active duty solely for
- 22 the purpose of participating in honor guard details for fu-
- 23 nerals of veterans shall not during the period of such re-
- 24 tention on active duty be counted toward the active duty

- 1 end strength limitation for that fiscal year for that mem-
- 2 ber's Armed Force.
- 3 (d) Workers' Compensation and Liability In-
- 4 SURANCE.—Section 1588(a) of title 10, United States
- 5 Code, is amended by adding at the end the following new
- 6 paragraph:
- 7 "(4) Voluntary services under section 1491 of
- 8 this title to participate in an honor guard detail for
- 9 the funeral of a veteran.".
- 10 (e) Support of Required State Functions.—
- 11 Section 114 of title 32, United States Code, is amended
- 12 by adding at the end the following: "Such use of appro-
- 13 priated funds may include support of State law require-
- 14 ments relating to National Guard participation in funerals
- 15 of veterans.".
- 16 (f) Effective Date.—The amendments made by
- 17 this section shall apply with respect to duty performed as
- 18 a member of an honor guard detail for the funeral of a
- 19 veteran, or training for such duty, on or after the date
- 20 of the enactment of this Act.
