### 106TH CONGRESS 1ST SESSION H.R. 2345

To consolidate in a single independent agency in the executive branch the responsibilities regarding food safety, labeling, and inspection currently divided among several Federal agencies.

### A BILL

- To consolidate in a single independent agency in the executive branch the responsibilities regarding food safety, labeling, and inspection currently divided among several Federal agencies.

#### 1 SECTION 1. SHORT TITLE; TABLE OF CONTENTS.

- 2 (a) SHORT TITLE.—This Act may be cited as the
- 3 "Safe Food Act of 1999".

#### 6 SEC. 2. FINDINGS AND PURPOSES.

7	(a) FINDINGS.—Congress finds the following:
8	(1) The safety and security of the food supply
9	of the United States requires efficient and effective
10	management of food safety regulations.
11	(2) The safety of the food supply of the United
12	States is facing tremendous pressures with regard to
13	the following issues:
14	(A) Emerging pathogens and the ability to
15	detect them.
16	(B) An aging population with a growing
17	number of people at high risk for foodborne ill-
18	nesses.
19	(C) An increasing volume of imported
20	foods, without adequate monitoring and inspec-
21	tion.

1	(D) Maintenance of adequate inspection of
2	the domestic food processing and food service
3	industry.
4	(3) Federal food safety inspection, enforcement,
5	and research efforts should be based on scientifically
6	supportable assessments of risks to public health.
7	(4) The Federal food safety system is frag-
8	mented, with at least 12 primary Federal agencies
9	governing food safety.
10	(b) PURPOSES.—It is the purpose of this Act—
11	(1) to establish a single agency, the Food Safe-
12	ty Administration, that will be responsible for the
13	regulation of food safety and labeling and for con-
14	ducting food safety inspections to ensure, with rea-
15	sonable certainty, that no harm will result from the
16	consumption of food, by preventing food-borne ill-
17	nesses due to microbial, natural, or chemical hazards
18	in food; and
19	(2) to transfer to the Food Safety Administra-
20	tion the food safety, labeling, and inspection func-
21	tions currently performed by other Federal agencies,
22	to achieve more efficient management and effective
23	application of Federal food safety laws for the pro-
24	tection and improvement of public health.

### 1 SEC. 3. DEFINITIONS.

2	For purposes of this Act:
3	(1) Administration.—The term "Administra-
4	tion" means the Food Safety Administration estab-
5	lished under section 4.
6	(2) Administrator.—The term "Adminis-
7	trator" means the Administrator of Food Safety ap-
8	pointed under section 4.
9	(3) FOOD SAFETY LAWS.—The term "food safe-
10	ty laws" means the following:
11	(A) The Federal Meat Inspection Act (21
12	U.S.C. 601 et seq.).
13	(B) The Poultry Products Inspection Act
14	(21 U.S.C. 451 et seq.).
15	(C) The Egg Products Inspection Act (21
16	U.S.C. 1031 et seq.).
17	(D) The Federal Food, Drug, and Cos-
18	metic Act (21 U.S.C. 301 et seq.), with regard
19	to food safety, labeling, and inspection under
20	that Act.
21	(E) Such other laws and portions of laws
22	regarding food safety, labeling, and inspection
23	as the President may designate by Executive
24	order as appropriate to consolidate under the
25	administration of the Administration.

3 (a) ESTABLISHMENT OF ADMINISTRATION; ADMINIS-TRATOR.—There is established in the executive branch an 4 5 agency to be known as the "Food Safety Administration". The Administration shall be an independent establish-6 7 ment, as defined in section 104 of title 5, United States 8 Code. The Administration shall be headed by the Adminis-9 trator of Food Safety, who shall be appointed by the Presi-10 dent, by and with the advice and consent of the Senate. 11 (b) RESPONSIBILITIES.—The Administrator shall ad-12 minister and enforce the food safety laws for the protec-13 tion of the public health and shall oversee the following functions of the Administration: 14

- (1) Implementation of Federal food safety inspection, enforcement, and research efforts, based on
  scientifically supportable assessments of risks to
  public health.
- 19 (2) Development of consistent and science-20 based standards for safe food.
- 21 (3) Coordination and prioritization of food safe22 ty research and education programs with other Fed23 eral agencies.
- 24 (4) Coordination of the Federal response to
  25 foodborne illness outbreaks with other Federal agen26 cies and State agencies.

(5) Integration of Federal food safety activities
 with State and local agencies.

# 3 SEC. 5. CONSOLIDATION OF SEPARATE FOOD SAFETY AND 4 INSPECTION SERVICES AND AGENCIES.

5 (a) TRANSFER OF FUNCTIONS.—For each Federal agency specified in subsection (b), there are transferred 6 7 to the Administration all functions that the head of the 8 Federal agency exercised on the day before the effective 9 date specified in section 8 (including all related functions 10 of any officer or employee of the Federal agency) that relate to administration or enforcement of the food safety 11 laws, as determined by the President. 12

13 (b) COVERED AGENCIES.—The Federal agencies re-14 ferred to in subsection (a) are the following:

15 (1) The Food Safety and Inspection Service of16 the Department of Agriculture.

17 (2) The Center for Food Safety and Applied18 Nutrition of the Food and Drug Administration.

19 (3) The Center for Veterinary Medicine of the20 Food and Drug Administration.

(4) The National Marine Fisheries Service of
the National Oceanic and Atmospheric Administration of the Department of Commerce as it relates to
the Seafood Inspection Program.

(5) Such other offices, services, or agencies as
 the President may designate by Executive order to
 further the purposes of this Act.

4 (c) TRANSFER OF ASSETS AND FUNDS.—Consistent with section 1531 of title 31, United States Code, the per-5 sonnel, assets, liabilities, contracts, property, records, and 6 unexpended balances of appropriations, authorizations, al-7 8 locations, and other funds that relate to the functions 9 transferred under subsection (a) from a Federal agency 10 shall be transferred to the Administration. Unexpended funds transferred pursuant to this subsection shall be used 11 by the Administration only for the purposes for which the 12 13 funds were originally authorized and appropriated.

14 (d) REFERENCES.—After the transfer of functions 15 from a Federal agency under subsection (a), any reference in any other Federal law, Executive order, rule, regulation, 16 document, or other material to that Federal agency or the 17 head of that agency in connection with the administration 18 or enforcement of the food safety laws shall be deemed 19 to be a reference to the Administration or the Adminis-20 21 trator, respectively.

(e) SAVINGS PROVISIONS.—The transfer of functions
from a Federal agency under subsection (a) shall not
affect—

(1) an order, determination, rule, regulation,
permit, agreement, grant, contract, certificate, license, registration, privilege, or other administrative
action issued, made, granted, or otherwise in effect
or final with respect to that agency on the day before the transfer date with respect to the transferred
functions; or

8 (2) any suit commenced with regard to that 9 agency, and any other proceeding (including a notice 10 of proposed rulemaking), or any application for any 11 license, permit, certificate, or financial assistance 12 pending before that agency on the day before the 13 transfer date with respect to the transferred func-14 tions.

# 15 SEC. 6. ADDITIONAL AUTHORITIES OF THE ADMINISTRA16 TION.

17 (a) OFFICERS AND EMPLOYEES.—The Administrator may appoint officers and employees for the Administration 18 in accordance with the provisions of title 5, United States 19 20 Code, relating to appointment in the competitive service, 21 and fix the compensation of the officers and employees 22 in accordance with chapter 51 and with subchapter III of 23 chapter 53 of such title, relating to classification and Gen-24 eral Schedule pay rates.

1 (b) EXPERTS AND CONSULTANTS.—The Administrator may procure the services of experts and consultants 2 3 as authorized by section 3109 of title 5, United States 4 Code, and pay in connection with the services travel ex-5 penses of individuals, including transportation and per diem in lieu of subsistence while away from the homes or 6 7 regular places of business of the individuals, as authorized 8 by section 5703 of such title.

9 (c) BUREAUS, OFFICES, AND DIVISIONS.—The Ad-10 ministrator may establish within the Administration such 11 bureaus, offices, and divisions as the Administrator may 12 determine to be necessary to discharge the responsibilities 13 of the Administration.

(d) RULES.—The Administrator may prescribe, in accordance with chapters 5 and 6 of title 5, United States
Code, such rules as the Administrator determines to be
necessary or appropriate to administer and manage the
functions of the Administrator.

# 19 SEC. 7. LIMITATION ON AUTHORIZATION OF APPROPRIA-20 TIONS.

For the fiscal year that includes the effective date of this Act, the amount authorized to be appropriated to carry out this Act shall not exceed—

(1) the amount appropriated for that fiscal yearfor the Federal agencies described in section 5(b) for

3	(2) the amount appropriated for these agencies
4	for such purpose for the preceding fiscal year, if, as
5	of the effective date of this Act, appropriations for
