A BILL

To provide that the Davis-Bacon Act shall not apply to contracts for the construction and repair of schools and libraries.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "School and Library
- 5 Construction Affordability Act".
- 6 SEC. 2. PURPOSE.
- 7 The purpose of the amendments made by this Act
- 8 is—

- 1 (1) to amend the Act of March 3, 1931 (40
- 2 U.S.C. 276a et seq.) (commonly referred to as the
- 3 Davis-Bacon Act) to make it inapplicable to con-
- 4 tracts for school or library construction and repair
- 5 and thereby reduce school construction and repair
- 6 costs by 5 to 38 percent and thereby saving funds
- 7 that can be used to improve education, repair and
- 8 construct modern schools and libraries, and provide
- 9 tax relief; and
- 10 (2) to harmonize Federal laws with a majority
- of the States.
- 12 SEC. 3. DAVIS-BACON ACT.
- The first section of the Act of March 3, 1931 (40
- 14 U.S.C. 276a) (commonly referred to as the Davis-Bacon
- 15 Act) is amended by adding at the end the following:
- 16 "(c) Subsection (a) does not apply to any contract
- 17 which is entered into to construct or repair facilities of
- 18 an educational agency or library.".
- 19 SEC. 4. COPELAND ACT.
- 20 Section 2 of the Act of June 13, 1934 (40 U.S.C.
- 21 276c) (commonly referred to as the "Copeland Act") is
- 22 amended by adding at the end the following: "This section
- 23 does not apply to any contractor or subcontractor which
- 24 is engaged in the construction or repair of facilities of an
- 25 educational agency or library.

1 SEC. 5. CONSTRUCTION.

- 2 Nothing in this Act or the amendments made by this
- 3 Act may be construed to diminish in any way the quality
- 4 of facility construction or repair or to affect Federal,
- 5 State, and local guidelines, codes, and regulations relating
- 6 to construction or repair quality.

7 SEC. 6. EFFECTIVE DATE.

- 8 The amendments made by sections 1 and 2 shall take
- 9 effect 30 days after the date of the enactment of this Act
- 10 but shall not affect any contract in existence on such date
- 11 of enactment or made pursuant to invitation for bids out-
- 12 standing on such date of enactment.
