A BILL

To reauthorize the Trade Adjustment Assistance Program through fiscal year 2001.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REAUTHORIZATION OF TRADE ADJUSTMENT**
4 **ASSISTANCE PROGRAM.**

5 (a) ASSISTANCE FOR WORKERS.—Section 245 of the
6 Trade Act of 1974 (19 U.S.C. 2317) is amended by strik-
7 ing “the period beginning October 1, 1998, and ending

1 June 30, 1999,” each place it appears and inserting “fis-
 2 cal years 1999, 2000, and 2001,”.

3 (b) ASSISTANCE FOR FIRMS.—Section 256(b) of the
 4 Trade Act of 1974 (19 U.S.C. 2346(b)) is amended by
 5 striking “the period beginning October 1, 1998, and end-
 6 ing June 30, 1999” and inserting “fiscal years 1999,
 7 2000, and 2001”.

8 (c) TERMINATION.—Section 285(c) of the Trade Act
 9 of 1974 (19 U.S.C. 2771 note) is amended in paragraphs
 10 (1) and (2)(A) by striking “June 30, 1999” and inserting
 11 “September 30, 2001”.

12 (d) TRAINING LIMITATION.—Section 250(d)(2) of
 13 the Trade Act of 1974 (19 U.S.C. 2330(d)(2)) is amended
 14 by striking “the period” and all that follows through
 15 “\$15,000,000” and inserting “any fiscal year shall not ex-
 16 ceed \$30,000,000”.

17 **SEC. 2. EXTENSION OF TIME FOR FILING PETITIONS FOR**
 18 **WORKER ASSISTANCE.**

19 Section 223(b)(1) of the Trade Act of 1974 (19
 20 U.S.C. 2273(b)(1)) is amended by striking “one year” and
 21 inserting “two years”.
