To expand the boundaries of the Gettysburg National Military Park to include the Wills House, and for other purposes.

3 (a) ~~IN GENERAL.—The Act entitled “An Act to revise~~

2 seq.) is amended—

3 (1) in section 1—

4 (A) by redesignating subsection (b) as sub-
5 section (c);

6 (B) by inserting after subsection (a) the
7 following:

8 “(b) ADDITIONAL LANDS.—In addition to the lands
9 identified in subsection (a), the park shall also include the
10 property commonly known as the Wills House located in
11 the Borough of Gettysburg and identified as Tract P02–
12 1 on the map entitled ‘Gettysburg National Military Park’
13 numbered MARO 305/80,011 Segment 2, and dated April
14 1981, revised May 14, 1999.”; and

15 (C) in subsection (c), as so redesignated,
16 by striking “in subsection (a)” and inserting
17 “in subsections (a) and (b)”; and

18 (2) in section 2, by striking “1(b)” each place
19 it appears and inserting “1(c)”.

20 (b) ACQUISITION AUTHORITY NOT EXPANDED.—
21 Nothing in this Act is intended to or may be construed
22 to grant the Secretary authority to acquire lands or inter-
23 ests in lands.

1 **SECTION 1. WILLS HOUSE ADDED TO PARK.**

9 *(B) by inserting after subsection (a) the fol-*
 10 *lowing:*

11 *“(b) ADDITIONAL LANDS.—In addition to the lands*
 12 *identified in subsection (a), the park shall also include the*
 13 *property commonly known as the Wills House located in*
 14 *the Borough of Gettysburg and identified as Tract P02–*
 15 *1 on the map entitled ‘Gettysburg National Military Park’*
 16 *numbered MARO 305/80,011 Segment 2, and dated April*
 17 *1981, revised May 14, 1999.”; and*

18 *(C) in subsection (c), as so redesignated, by*
 19 *striking “in subsection (a)” and inserting “in*
 20 *subsections (a) and (b)”;* and

21 *(2) in section 2, by striking “1(b)” each place it*
 22 *appears and inserting “1(c)”.*
